5. DEPUTATIONS**5.1 Dan Sadler, Accessibility Supervisor to present on the Multi-Year Accessibility Plan 2020 Accessibility Annual Status Update (Related to Item 8.3)**

Dan Sadler, Supervisor Accessibility presented and provided an overview on the Multi-Year Accessibility Plan. Mr. Sadler spoke about the key commitments and achievements for 2020 based on the Integrated Accessibility Standards Regulation's general requirements and the customer service, information and communication, employment, transportation and design of public spaces standards.

Members of the Committee spoke to the matter, and were very happy with the overall progress of the plan and raised the following questions and concerns:

- Increase Winter Maintenance on snow and curb clearing;
- Ensure accessibility signals at intersections are wheelchair accessible;
- Review elevator standards at transit terminals;
- Applauded the move to ZOOM as the virtual meeting platform for AAC meetings;
- Applauded hiring interpreters for Mayor's Press Conferences; and
- Applauded the accessibility imagery in the Plan as it represents the community and is identifiable.

Dan Sadler responded to the questions from the Committee.

Naz Husain, Chair requested to schedule a session post the Pandemic to discuss the biggest accessibility challenges during the COVID-19 pandemic.

Anita Binder, Stakeholder Member, inquired about the affect of the pandemic on accessible employment and how the City of Mississauga is addressing those concerns. Mr. Sadler responded by noting that he would provide a follow up response.

DIRECTION to Accessibility staff to schedule a meeting with the Members of the Accessibility Advisory Committee to conduct a deep dive discussion regarding the accessibility challenges faced during the COVID-19 Pandemic.

Micromobility Program Development

- 3 Phase Project
- Phase 1: Visioning and Interim E-scooter Strategy
- Phase 2: Shared Micromobility Systems Research and Recommendations - **We are Here**
- Phase 3: Shared Micromobility Systems Implementation and Business Plan



Phase 1: Interim E-scooter Strategy

- To evaluate e-scooter use and experiences in Mississauga
- The Province of Ontario launched a five-year pilot program allowing e-scooters to operate on roadways
- Mississauga has “opted-in” by adopting / amending local bylaws



Phase 1: Interim E-scooter Strategy

- Can be operated:
 - On roads with posted speed of 50 km/h or less
 - On designated cycling infrastructure in the road right-of-way (bicycle lanes, multi-use trails)
- Can not be operated:
 - On roads with posted speed limit of 60 km/h or more
 - On sidewalks
 - On park trails or multi-use trails in parks
 - On City property (City facilities, transit terminals)



Additional Elements

- Education and Engagement
 - Feedback will help inform future decisions about the Micromobility program
- Enforcement
 - Split responsibility between Peel Police, City By-law Enforcement, and City Security Services
- Monitoring

- YourSay Website
- Social media
- Infographics
- Regular touchbases with Advisory Committees



What's Happening Elsewhere - Updates

- Ottawa – E-Scooter Pilot renewed for 2021; sidewalk riding has been an issue
- Hamilton – E-scooters now permitted under similar conditions to Mississauga, Ottawa etc
- Toronto – E-Scooter report still outstanding
- Windsor – E-Scooter report scheduled for spring
- Waterloo Region – consulting with public on preferred approach



Micromobility Phase 2

- Intending to hire a full-time Project Lead (contract position) to lead the overall project including engagement on e-scooters
- Retaining a consultant team to provide technical support
- Report back to General Committee later in 2021 with recommendations and results of feedback received on e-scooters
