6. PUBLIC QUESTION PERIOD - 15 Minute Limit

Jonathan Giggs, Resident spoke to item 8.3 and requested further clarification on the number of planned cycling infrastructure projects that had been cancelled due to concerns regarding traffic capacity. Mr. Giggs noted that staff could answer his question during the discussion of item 8.3.

Natalie Halff, Resident spoke to item 5.2 and enquired about the status of the investigation for the cyclist fatality on July 20, 2020, which was not included in the data. Sergeant Garry Rawlinson, Peel Regional Police advised that the fatality was investigated and the collision was reclassified as a pedestrian fatality as the person was not on their bicycle at the time of the collision.

Glenn Voakes, Resident spoke to item 8.3 and enquired about the City's plan to complete the proposed bicycle lanes since some of the projects had been cancelled. Fred Sandoval, Active Transportation Coordinator advised that the memorandum provided an update on the implementation of the recommended bicycle lanes outlined in the framework report and that the City would continue to seek consultation on the planning that was still underway.

Dorothy Tomiuk, Resident spoke to item 8.4 and enquired about the status of the ICIP projects and further enquired if applications to both the ICIP and the new National AT Fund, and any other grant opportunities could be tracked in an ongoing chart format. Robert Leuschner, Citizen Member recommended that Active Transportation staff be requested to create a chart to track the status of grant funding.





Project Update Meeting, March 3rd, 2021

Overview of safety considerations for cyclists

Key Takeaways:

- Cycling access is desired, including a connected network, and adequate infrastructure (parking)
- A crosswalk was contemplated for pedestrian safety at Lakeshore Road and Front Street, but following traffic review was not approved.
- There are concerns about the underpass flooding and the potential need to elevate the boardwalk, however current elevation and the height of the bridge cannot accommodate any additional elevation

While there will be pedestrian enhancements to the foot path underneath the bridge, this trail should also accommodate cyclists via multi-use recreational trail design. It was discussed that traffic calming measures at-grade at Lakeshore Road and Front Street North might be needed, but that falls out of the scope of this project. Currently we propose a connection at John Street.





6.3 Proposed Cycling Network

The 2018 Cycling Master Plan envisions a comfortable, connected and convenient cycling network that includes separated bike lanes, cycle tracks, multi-use trails, conventional bike lanes and shared routes as summarized in **Table 6**. Once implemented, these facilities will create a cycling network that Mississauga residents and visitors of all ages and abilities will feel comfortable using.







The City of Mississauga has an annual cycling program for the installation of cycling infrastructure by the Transportation and Works (T&W) department (along street rights-of-way) and the Community Services (CMS) department (outside of street rights-of-way). The Cycling Program is consistent with the 2018 Cycling Master Plan.


The Transportation & Works department has identified 4.17 km of new cycling infrastructure projects to be funded from the 2020 Capital Budget allocation. Currently, 1.76 km (42%) of this infrastructure is complete and an additional 0.20 km is under construction. This year, the T&W department plans to construct 10.22 km of new cycling infrastructure from the 2021 Capital Budget allocation. Currently, 0.0 km (0%) of this infrastructure is complete or under construction. The T&W department has planned for an additional 2.66 km of new cycling infrastructure as part of their Ongoing Projects. Currently, 0.0 km (0%) of this infrastructure is complete or under complete or under construction.

The Community Services department plans to implement 22.36 km of off-road trails throughout the city. At this time, 12.30 km (55%) of this infrastructure is complete and 3.80 km is under construction.

An additional 9.71 km of cycling infrastructure is planned to be constructed by the Region of Peel or Ministry of Transportation (MTO). 6.17 km (64%) of this infrastructure is complete and 3.54 km is currently under construction.

Cycling infrastructure is being implemented with ongoing funding from the City of Mississauga and Region of Peel. The City of Mississauga has also applied for funding through the Investing in Canada Infrastructure Program - Public Transit Stream and the Investing in Canada Infrastructure Program - COVID-19 Resilience Stream.

Note that the nature and schedule of the projects listed here are subject to change in accordance with budget, engineering and construction constraints, public consultation and Council approval. All lengths are shown in kilometres, measured along the road centreline (except for off-road trails), from the centre of intersections. Actual paved surface length may differ.

APPENDIX A: Project Status Definitions

Planning & Design – The project scope and design elements are being developed. This phase includes site assessments, public and internal engagement, conceptual design creation, detailed design creation, traffic analysis, and project feasibility assessments.

Design Complete - The project scope and detailed design are finalized.

Scheduled – The construction contract has been awarded. The construction start date is scheduled.

Under Construction - The project is actively being constructed.

Complete – The project is substantially completed and open to the public for use. All regulatory signage (example: reserved bicycle lane signage, shared path signage, cyclist dismount signage) and markings (example: crossrides, bicycle and diamond stencil) have been installed. Non-regulatory signage (example: wayfinding signage) and markings (example: trail centre line) may be pending.

On Hold – The project is on hold but still scheduled for the program year.

Deferred – The project has been postponed to a later program year.

Cancelled – The project will no longer take place.
