Item 9.15 - Single Source Designation for the Supply and Delivery of City Standard Intelight Traffic Signal Controllers from Tacel Ltd.

Innovative Traffic Solutions, Inc. would like to thank the city for providing us this opportunity to address Council.

In response to 9.15 Appendix #1 "Tacel Itd Intelight Traffic Controllers. - Statement of Work", Innovative Traffic Solutions, Inc respectfully requests and believes that it is in the City's best interest to not proceed with the single source contract for Intelight controllers. There are other traffic controllers that should be evaluated for the city's consideration. This procurement should be released as a public tender, and it is in the best interest of the City of Mississauga to receive the most qualified and cost-effective traffic controller solution for the City's ISO 37122 "Indicators for Smart Cities". The following items support this request:

- Procurement No: FA.49.314-13 for Traffic Signal Control System Replacement, Long Term Support Services and ATMS) – Awarded to Parsons Inc in December of 2014.
 - There are other controller manufacturers that were tested during this ATMS RFP like the McCain Inc eX series controller that successfully can communicate with Parsons iNET system meeting all NTCIP standard and priority object sets and meet or exceed the City's requirements to compliment the City's ISO 37122 certification for Smart Cities.
 - Examples of other Parsons iNET ATMS end users that currently communicate with different/multiple controller manufacturers are Halifax Regional Municipality (HRM), NS and City of London, ON. Parsons selected the McCain eX series controller based on the performance and cost effectiveness for these projects.
- The per unit dollar amount for the Intelight traffic controller as per GC-0323-2021,
 Item 9.15 appendix #1 are as follows:
 - Year 2020 \$4,345.00 per Intelight traffic controller (x 20 = \$86,900.00)
 - Year 2021 \$4,450.00 per Intelight traffic controller (x 27 = \$120,150.00)
- The per unit price listed above represents, at minimum, a 30% premium for similar controllers from other manufacturers who meet/exceed the Intelight controller functionality.
 - Comparing to similar traffic controllers procured through public tender, the City can expect to see the following per unit dollar value for year 2021 and 2022:
 - \circ Year 2021 \$3,400.00 per traffic controller (x 27 = \$91,800.00). This is almost a \$30,000.00 per year savings for the City of Mississauga.

- The following data, gathered from public bid sites or in person bid results, support our assertion that the City of Mississauga will be paying in excess of at minimum \$1,000.00 more for the Intelight traffic controller than other Canadian cities.
 - RFQ Number: 19H274 Halifax Regional Municipality Oct 17, 2019. Tacel was awarded at a per unit price of \$2,682.00/ea.
 - o RFT Number: C11-58-17 City of Hamilton September 14, 2017. Tacel was awarded at a per unit price of \$2,070.70/ea.

The above information is provided to the city so you may revaluate your position for a sole source award to Tacel for traffic controllers procured at a higher cost than other municipalities in Canada utilizing a competitive tendering process.

Not only does the price factor play an important role in this request, but since the initial controller evaluation took place in 2014/2015, technology has advanced and there are many other solutions available that should be considered to help continue the City's vision into their smart city initiatives.

MOTION

WHEREAS the use of cannabis products is legal in Canada;

WHEREAS the sale of cannabis products is legal through stores approved by the Alcohol and Gaming Commission of Ontario (AGCO) as appointed by the Government of Ontario;

WHEREAS The Council of the City of Mississauga passed a resolution to prohibit retail cannabis stores within the City, December 2018 and again June 9, 2021;

WHEREAS under the Municipal Act 2001 municipalities are the exclusive authority for zoning and the licensing of businesses within their jurisdictions;

WHEREAS the Province lifted the cap on the number of licences that can be issued by AGCO March 2, 2019 resulting in the number of stores in Ontario increasing from 30 to 772 as of June 9, 2021;

WHEREAS the AGCO website shows it is approving approximately 30 new locations per week and has not refused a single application based on an objection presented by a Municipal Council including 29 objections by the City of Hamilton which has 47 cannabis stores;

WHEREAS the Council of the City of Mississauga is extremely concerned about the proximity of legal cannabis stores to playgrounds, counselling facilities, child care and community centres to name a few sensitive sites:

WHEREAS the Council of the City of Mississauga regulates the "clustering" of a variety of businesses and services such as group homes, dental clinics, veterinary hospitals etc. but has no local say on the concentration of legal cannabis stores in our City;

THEREFORE BE IT RESOLVED:

A request on behalf of the Council of the City of Mississauga be forwarded to the Premier of Ontario asking for a reconsideration of the exclusive powers of the AGCO regarding the zoning of legal cannabis stores, recognizing the traditional role of municipalities in such matters as number and location of retail businesses; and further

This motion be sent to the Cities of Oakville, Markham and Vaughan as well as to the six MPPs for the City of Mississauga and the Leaders of all Provincial Parties.
