# Bicycle Parking

#### Bicycle Parking Zoning By-law Directions study

#### **Purpose**

Introduce bicycle parking as a requirement for all new developments

#### **Approach**

- Review practices in other jurisdictions in Ontario and Canada
- Establish bicycle parking rates and regulations that are tailored to Mississauga
  - City Centre higher bicycle parking rates
  - Rest of City standard bicycle parking rates
- Provide direction on other requirements
  - Minimum dimensions
  - Access, location, and proximity to building entrances





# Bicycle Parking

#### Land use considerations:

- Residential: Apartments, townhouses (without exclusive garages), and other multi-unit buildings
- Non-residential: Retail, offices, employment, schools, institutional uses

#### User considerations:

- Long-term bike parking: residents, employees
- Short-term bike parking: visitors, customers
- End-of-trip facilities: showers, changerooms at workplaces



# SCOPE OF THE PROBLEM

2019 statistics put the number of bikes stolen at more than 2 million in North America. One bike stolen every 15 seconds.

It costs society \$1 billion a year.

A McGill University paper on bike theft revealed that 20% of respondents had bikes stolen 3 times and that only 1.6% were recovered.

In 2020 over 4000 bicycles were reported stolen in Toronto. That is roughly 3 times more than in 2014.

# BCAC'S ROLE IN REDUCING BIKE THEFT.

The way bike theft is treated trivializes it as a low level property crime resulting in under reporting and lack of concentration of police resources on this problem. Frustration with multiple thefts has resulted in some riders giving up cycling.

Under our mandate of encouraging cycling in the city we should be promoting proven methods to reduce bicycle theft.

Having a strategy to address bike theft is part of being a bicycle friendly community.

# EXPLORING A SOLUTION.



This is Detective Rob Brunt of the Vancouver Police Service and J Allard, an ex Microsoft executive who led the team that designed the Xbox. Together they collaborated to develop a plan to reduce bike theft in cities in North America. Their plan involves a universally accessible bicycle registration website along with co-operation from bike shop owners, cycling advocates and, most importantly, police.

# HOW IT WORKS.

One of the cornerstones of this plan is the use of the 529 Garage website bicycle registry. It far out performs any municipal police localized registry. Then the assistance of bike shop owners and cycling advocates is needed to encourage the use of the bicycle registration website, and to encourage the community to make changes to reduce opportunities for theft. The most important aspect is the police adoption of the website as well as allocating resources to facilitate a plan to reduce theft.

# RESULTS.

With the application of Brunt and Allard's plan in Vancouver, previously a bicycle theft hotspot, was an eventual reduction of reported bicycle theft of 40%.

Although uptake of this plan has been slow, it has already been adopted by police departments in Canadian cities like Ottawa, Regina, Brandon and many municipalities in British Columbia.

I would like your support before I approach the Peel Regional Police organization regarding the possibility of adopting this twenty first century strategy to the problem of bicycle theft.

Subject: Share the Trail Campaign

#### **Background**

The City of Mississauga frequently receives concerns from residents regarding conflicts between pedestrians and cyclists using the City's shared trail network.

In response to the observed increase in the use of shared trails due to COVID-19 restrictions, Staff developed a Share the Trail campaign in 2020 as a way to educate residents on safe and courteous trail use.

#### **Campaign Messaging**

In June 2020, City of Mississauga Staff developed a list of trail etiquette messages based on research from surrounding municipalities. Staff were careful to tailor Share the Trail messaging to the specific concerns of Mississauga residents.

#### **Campaign Elements**

The Share the Trail campaign featured both online and in-person components. The online portion of the campaign was rolled-out through the City's Twitter and Facebook social media channels, a media pitch, and e-newsletters that were sent to various City email subscription lists. A Council Corner article was also published so City Councillors could share trail etiquette messaging with residents in their ward.

The in-person component of the Share the Trail Campaign included implementing pilot signage on the trail systems and collecting feedback from residents. Pilot signs were installed at 25 locations within the Lake Aquitaine and Lake Wabukayne trail systems, and a Share the Trail webpage was created to collect feedback on the signage. Once COVID-19 gathering restrictions were lifted, the City's Bike Ambassadors set up pop-up booths along the trail to engage with residents, collect feedback, and provide education material related to the Share the Trail Campaign.

#### Signage Development and Installation

Three key messages were identified as most appropriate for the signage portion of the campaign: Slow down when passing; Use your bell; and Stay right, pass left.

City of Mississauga staff developed signage to highlight the three key messages. The graphics developed were designed to bear a resemblance to the City's existing Wayfinding signage and to be consistent with Mississauga Park Signage Guidelines. By late August 2020, the signage was finalized and approved by MCAC, Councillor Fonseca, and Councillor Saito.

In early October 2020, the City installed the Share the Trail signage as shown in *Figures 1* and 2 below along the Lake Wabukayne and Lake Aquitaine Trail systems.

#### **Share the Trail Survey**

In November of 2020, a Share the Trail webpage and feedback tool was created on the Mississauga Bikes website. The brief survey encouraged residents to provide comments on the design and practicality of the pilot signage as well as share any concerns they felt should be addressed to ensure residents respectfully shared the trail.

In order to promote the new trail signage and increase the amount of feedback received from residents, City staff promoted the pilot signage and survey on social media and set up pop-up booths along the signed trails around Lake Aquitaine and Lake Wabukayne to engage with the community as they used the trails. The following information is a summary of the feedback received by the City during the engagement period.

#### **Survey Results**

For an eight (8) month period, feedback was collected from residents and a total of 137 responses were received. As shown in Figure 3 below, the majority of survey respondents indicated that the messages on the sign were easy to understand.





Seven of the responses noted that the turtle symbol was confusing and thought it indicated a turtle crossing. Some residents noted that the image on the far right of the sign was unclear if looked at without the text.

Another question on the survey asked if the most important share the trail messages were included on the sign, and respondents largely agreed, as is seen in Figure 4 below.

#### Do you believe these are the three most important messages to have included on the sign?



The most consistent concern residents raised was that the signs were hard to notice. Many of those surveyed indicated that the sign should be larger so that it would be more noticeable. A few respondents noted that larger text would be especially helpful for the signs to be legible for older adults and those visually impaired. Additionally, residents also recommended that signs be installed at eye level.

A common suggestion residents made to improve trail etiquette was to pair pavement markings with the signage. Feedback indicated that markings delineating the centre of the path and directional arrows along the trail would be helpful to remind trail users to keep right.

All resident feedback will be taken into consideration; however, not all feedback can be incorporated due to signage and Accessibility for Ontarians with Disabilities Act (AODA) standards and requirements.

#### **Next Steps & Timeline**

Active Transportation staff will be responsible for coordinating any changes to the sign design based on feedback received through the pilot process. The signage will then be available for implementation at additional locations. Responsibility for future Share the Trail requests and installations will be handed over to Parks, Forestry and Environment staff.

Matthew wanted to share with you a concern about the Tenth Line bike lane at Britannia.

I got an e bike this summer and finally ventured a little further from home this weekend. I got to the Britannia multi use trail at Winston Churchill and headed east to Tenth Line to go north. As an aside this trail is in bad shape and I am asking the Region to fix some areas.

When I got to Tenth Line I found it difficult for me as a relatively new rider to access the lane on the road. The bike lane does not start right at the corner but a little north of it, there are no obvious markings (ie green paint) on the road as other cities have done to show the lane starts.

I stopped at the light and had to go into the intersection on my bike and then was in the travelled northbound lane to get into the actual bike lane. As there was turning traffic I felt rather vulnerable doing this maneuver and I am sure I would not be the only one...which may be why I see so many riding on the sidewalk along Tenth Line from the trail.

I am not sure what would help - I would have felt more secure had I been entering right onto the bike lane and if the bike lane was more clearly indicated to drivers.

I am sharing this with Councillor Fonseca and asking her to get some input from the committee on their feelings about this. There are many like me who are seniors, women and who are getting back on bikes for exercise after many years and this is who we need to design for according to all experts and in this case we are not.

Greetings,

On behalf of the City of Mississauga, I am writing to provide our comments on the National Active Transportation Strategy and Fund.

#### National Active Transportation Strategy

The City is pleased to see that the Federal Government's framework for the National AT Strategy captures so many critical elements. In particular, we are supportive of and would like to emphasize the following:

- Experience equity in community engagement, project planning, design and operation of any government project, let alone active transportation, has never been more critical and never been more obviously required. The pandemic has forcefully opened our eyes to the inequitable circumstances that many find themselves victim to in our communities. Only by placing equity at the heart of what we do can we hope to make positive changes for all of those within our communities.
- Road Safety the Federal Government has an important role to play in overall road safety, which should be reoriented with a focus on protecting vulnerable road users. For example, vehicle safety standards have a direct impact on the safety of pedestrians and cyclists. Vehicle design and dimensions, such as front end height, can affect the driver's visibility of vulnerable road users and the consequence of a collision with a pedestrian or cyclist. For example, mandating side guards for heavy trucks can protect pedestrians and cyclists from serious injury or death. Limiting indash entertainment system options could reduce distracted driving. The Federal Government should incorporate the goals and values from the Active Transportation Strategy into all aspects of transportation regulation.

- Land Use active transportation is most feasible in communities that are built in
  ways that facilitate and encourage short distance trip making. The City of
  Mississauga is among the most rapidly urbanizing cities in Canada, and we
  understand the importance of supportive land use policies to increasing active
  transportation uptake. The Federal Government should consider the impact of any
  land use proposals or specific projects it reviews through the lens of active
  transportation.
- Public Health as the only Canadian municipality participating in the Cities
   Changing Diabetes Programme, the City of Mississauga is committed to initiatives
   that improve the health of people in our community. Active Transportation is one of
   several initiatives that help tackle high rates of diabetes and put health at the centre
   of City policies to support a healthier society. The Federal Government should put
   equal emphasis on health in the AT Strategy.
- Data the framework for the National AT Strategy acknowledges that data-driven and evidence-based decision-making is critical; the Census has tremendous potential to give City staff and decision-makers more reliable and timely data on transportation behaviour. Consider transportation-focused surveys like the Transportation Tomorrow Survey for examples of what type of detailed information is valuable.

#### National Active Transportation Fund

The City is eager to partner with the Federal Government to advance the proposed cycling and pedestrian networks that have been identified in our Cycling Master Plan (2018) and Pedestrian Master Plan (2021). The Federal Government should consider the following when reviewing submissions to the Fund:

- Not Just "Shovel-Ready" While we acknowledge that the National AT Fund is a stimulus fund, we strongly encourage the Federal Government to be flexible in both its review of projects submitted by municipalities, and also in its ongoing monitoring and evaluation of projects submitted. While municipalities will no doubt be keen to apply for funding of shovel-ready projects, the reality is that most municipalities do not have a supply of shovel-ready projects on the shelf waiting to be funded. Therefore, the Federal Government should allow for municipalities to undertake planning, design and public engagement work for projects submitted for consideration.
- Vision Zero The City of Mississauga is committed to the principles of Vision Zero, and is advancing strategic priorities that will work towards our goal of zero fatal and serious injury collisions on our roadways. Projects eligible for funding should emphasize not only the inclusion of linear active transportation infrastructure, but should also seek to improve overall road safety, consistent with the goals of Vision Zero.

I would be pleased to speak with you further regarding these comments if you have any questions or concerns. The City of Mississauga is excited to continue partnering with the Federal Government to improve active transportation for our residents.


