7. PUBLIC QUESTION PERIOD - 15 Minute Limit

Megan Piercey, Legislative Coordinator stated questions from residents that registered for public question period at the previous meeting on August 10, 2021 that failed for lack of quorum.

Question 1 (Item 9.4): Resident enquired about why the City limits cyclists to 3 metre wide crushed stone/paved roads through natural areas instead of single track trails. Jamie Ferguson, Manager, Parks Services advised that the master plan is reviewed in 5 year increments over 10 years, with the last review completed in 2019. Mr. Ferguson further advised with bench-marking staff did find that the City's trails continue to be used and are sought after, and noted that the City does have different trail construction proposed in the future.

Question 2 (Item 9.1): Resident enquired about whether Epic Tour has been paid in accordance with their 5 year contract with the City to operate the Tour de Mississauga. Matthew Sweet, Manager, Active Transportation advised that staff are working with Epic Tours as per the contract. Mr. Sweet noted the terms of the contract are confidential and that Danica Spencer, Epic Tours would be providing a verbal update on the 2021 Tour de Mississauga as item 9.1 on the agenda.

Question 3 (Item 9.4): Resident enquired if the City recognised that a reliable, sustainable network of trails caters to the public and reduces the number of unsanctioned trails built without permission? The resident further enquired about the City's plan to build off-road, unimproved cycling infrastructure and how would it be facilitated? Jamie Ferguson, Manager, Parks Services advised that the City is currently working on a future designated mountain bike course and noted that they would be working with Park Planning staff to develop the course.



Overview - World Day of Remembrance for Road Traffic Victims

World Day of Remembrance for Road Traffic Victims is November 21. This portion of the campaign will:

- Reflect on the impact collisions have on victims, their families and emergency services crews in Mississauga
- Show how the City is continuing to make moving through Mississauga safe, affordable, accessible and sustainable for all road users

Campaign | Project Goals

- Use speeding consequences to encourage drivers in Mississauga to slow down to create safer roads for pedestrians, cyclists, passengers, transit users and drivers
- Provide an opportunity to reflect on the impact that road collisions have on victims, their families and emergency services crews/first responders who deal with the aftermath of road collisions.

Campaign | Communications Goals

- Raise awareness among all road users about the consequences of speeding and encourage all road users to follow the rules of the road
- Inform residents about the prevalence of road collisions in Mississauga and the impact it has on the victim, their family and emergency services crews
- Share information about the actions the City of Mississauga is taking to prevent road collisions and the efforts to continue to make roads safe for all road users

Campaign | Key Messages

- Speeding has consequences for many Mississauga residents
 including their family, friends and loved ones.
- Mississauga is commemorating the World Day of Remembrance of Road Traffic Victims on November 21, 2021.

Subject: 2021 Quarterly Cycling Program Update (Q3)

The City of Mississauga has an annual cycling program for the installation of cycling infrastructure by the Transportation and Works Department (T&W) along street rights-of-way and the Community Services Department (CMS) outside of street rights-of-way (e.g. parks). The Cycling Program is consistent with the 2018 Cycling Master Plan.

T&W has identified 4.17 km of new cycling infrastructure projects to be funded from the 2020 Capital Budget allocation. Currently, 3.72 km (89%) of this infrastructure is complete and an additional 0.20 km is under construction. As part of the 2020 COVID-19 Recovery Framework projects, T&W proposed to construct 17.90 km of new cycling infrastructure. Thus far, 5.00 km (28%) of this infrastructure is complete and an additional 0.70 km is under construction. 4.30 km of the originally proposed infrastructure has been cancelled and is proposed for a future year's capital program.

T&W has identified 10.22 km of new cycling infrastructure projects to be funded from the 2021 Capital Budget allocation. Currently, 0.0 km (0%) of this infrastructure is complete and 0.39 km is under construction. T&W has planned for an additional 2.66 km of new cycling infrastructure as part of their Ongoing Projects. Currently, 0.0 km (0%) of this infrastructure is complete or under construction.


CMS plans to implement 22.36 km of off-road trails throughout the city. At this time, 12.86 km (58%) of this infrastructure is complete and 3.80 km is under construction.

An additional 8.86 km of cycling infrastructure is planned to be constructed by the Region of Peel. 5.32 km (60%) of this infrastructure is complete and 3.54 km is currently under construction.

Cycling infrastructure is being implemented with ongoing funding from the City of Mississauga and Region of Peel. The City of Mississauga has also been approved for funding through the Investing in Canada Infrastructure Program - Public Transit Stream and Resilience Stream.

Note that the nature and schedule of the projects listed here are subject to change in accordance with budget, engineering and construction constraints, public consultation and Council approval. All lengths are shown in kilometres, measured along the road centreline (except for off-road trails), from the centre of intersections. Actual paved surface length may differ.

Appendix A: Project Status Definitions

Planning & Design – The project scope and design elements are being developed. This phase includes site assessments, public and internal engagement, conceptual design creation, detailed design creation, traffic analysis, and project feasibility assessments.

Design Complete - The project scope and detailed design are finalized.

Scheduled – The construction contract has been awarded. The construction start date is scheduled.

Under Construction – The project is actively being constructed.

Complete – The project is substantially completed and open to the public for use. All regulatory signage (example: reserved bicycle lane signage, shared path signage, cyclist dismount signage) and markings (example: crossrides, bicycle and diamond stencil) have been installed. Non-regulatory signage (example: wayfinding signage) and markings (example: trail centre line) may be pending.

On Hold – The project is on hold but still scheduled for the program year.

Deferred – The project has been postponed to a later program year.

Cancelled – The project will no longer take place.
