## Subject

Extending the operation and enforcement of the City's Mandatory Face Covering By-law 0169-2020 and the City's COVID-19 Related Measures for Restaurants and Drinking Establishments By-law 0194-2020 to January 20, 2021

## Recommendation

- 1. That the report of the City Solicitor dated September 1, 2020 entitled "Extending the operation and enforcement of the City's Mandatory Face Covering By-law 0169-2020 and the City's COVID-19 Related Measures for Restaurants and Drinking Establishments By-law 0194-2020 to January 20, 2021 " be received for information.
- 2. That the City's Mandatory Face Covering By-law 0169-2020 and the City's COVID-19 Related Measures for Restaurants and Drinking Establishments By-law 0194-2020 be amended to extend operation and enforcement until January 20, 2021.

## Background

On July 8, 2020, Council enacted the COVID-19 Mandatory Face Covering By-law 0169-2020. This by-law requires all persons (subject to some exceptions) to wear a face covering inside buildings where the public is ordinarily invited or permitted access. This includes retail stores, indoor sports and recreational facilities, apartments and condominiums.

On August 5, 2020, Council enacted the COVID-19 Related Measures for Restaurants and Drinking Establishments By-law 0194-2020. This by-law established additional measures for restaurants and bars, including limiting capacity to 100 persons and limiting each table used by patrons to 10 persons. Both by-laws were enacted pursuant to the recommendations made by Dr. Loh, the Medical Officer of Health for the Region of Peel, to help mitigate the spread of COVID-19.

## **Present Status**

Following the enactment of the COVID-19 Mandatory Face Covering By-law 0169-2020 and the COVID-19 Related Measures for Restaurants and Drinking Establishments By-law 0194-2020 (collectively the "COVID-19 By-laws"), Enforcement staff have reported that property and business owners have responded positively and were brought into compliance with the assistance of an Inspection Officer.

The following table provides an overview enforcement statistics related to the COVID-19 Mandatory Face Covering By-law and the COVID-19 Related Measures for Restaurants and Drinking Establishments By-law starting from July 10, 2020 to present:

## Comments

The COVID-19 By-laws are to remain in force and effect until 12:01 a.m. on October 1, 2020. On September 8, 2020, Dr. Hau, the Associate Medical Officer of Health, for the Region of Peel (on behalf of Dr. Loh), sent a letter to the Mayors of the lower-tier municipalities in the Region of Peel recommending that the COVID-19 By-laws be extended until the end of 2020 (see Appendix 1). As a result, staff are recommending that the COVID-19 By-laws be amended to extend operation and enforcement until January 20, 2021, which is the first scheduled meeting of City Council of 2021.

## **Financial Impact**

There are no financial impacts.

## Conclusion

Council has enacted the Mandatory Face Covering By-law 0169-2020 and the City's COVID-19 Related Measures for Restaurants and Drinking Establishments By-law 0194-2020 to help mitigate the spread of COVID-19 in the City of Mississauga. Enforcement staff have reported that the public has for the most part complied with these by-laws.

Based on the recommendations of Dr. Hau, the Associate Medical Officer of Health for the Region of Peel, staff are recommending that these by-laws be amended to extend the operation

#### APPENDIX 1

September 8, 2020

Dear Mayors Brown, Crombie and Thompson,

Thank you for your support in our ongoing pandemic response to protect the health and safety of Peel residents. With your strong leadership, we have averted a worst-case scenario in Peel and have positioned our Region well for reopening and recovery. This includes the passing of temporary by-laws mandating mask use/face coverings and restricting capacity in restaurants and drinking establishments.

Due to the continued presence of the virus in our community, the progression of reopening and the resurgence of cases in Peel over the past week, my public health advice is that local municipal by-laws mandating the use of face coverings and imposing capacity restrictions on restaurants and drinking establishments continue in force until the end of 2020. We continue to closely monitor the virus in our community and will provide regular updates to municipalities to help inform Council decisions regarding the continuation and/or repeal of these temporary by-laws.

Similar by-laws are in place in other Ontario jurisdictions and a number of these jurisdictions are keeping these practices in place beyond October 1st (e.g. York, Ottawa). Alignment with neighbouring jurisdictions enables consistency for residents, businesses and visitors across municipal borders.

As the virus continues to circulate in our community, continued vigilance is critical to minimizing community spread. As Peel reopens, in accordance with the Provincial Framework, including the reopening of schools in September, some public health measures, such as physical distancing, are more challenging. Continuing public health measures, such as the use of non-medical masks/face coverings and capacity limits in indoor spaces where mask use is limited (i.e. restaurants and drinking establishments) is increasingly important in reducing the spread of COVID-19, minimizing the resurgence of cases, and mitigating a second wave.

Non-medical masks/face coverings that cover the mouth, nose, and chin without gapping remain an effective public health measure in controlling COVID-19 at its source by preventing the spread of respiratory droplets that may contain COVID-19 from the wearer to others. This is especially important in situations where physical distancing is difficult.

Due to limited mask use in restaurants and bars, these establishments remain a significant concern as our community continues to reopen. Measures to support these establishments in maintaining physical distancing, such as occupancy limits, can help to further reduce COVID-19 transmission.

It is my recommendation that local by-laws mandating the use of face coverings and imposing capacity restrictions in restaurants and drinking establishment be extended by all local municipalities in Peel until the end of 2020.

The Planning and Development Committee presents its eighth report for 2020 and recommends:

#### PDC-0029-2020

That the report dated August 14, 2020, from the Commissioner of Planning and Building regarding the applications by National Homes (1240 Britannia) Inc. and Mattamy (Country Club) Ltd. to permit 108 townhomes and one single detached home, under Files OZ 20/004 W6 and T-M20001 W6, 1240 Britannia Road West, be received for information.

#### PDC-0030-2020

- 1. That the applications under File OZ 18/011 W5, Pinnacle International (Ontario) Ltd., 0 and 5044 Hurontario Street to amend Mississauga Official Plan (MOP) and to change the zoning as follows:
  - a. Amend Map 13-4 to delete the existing floor space index (FSI) range between 1.9 to 2.9;
  - b. Amend Residential High Density Special Site 6 of the Uptown Major Node Character Area to permit a maximum of 2,370 dwelling units, a minimum of 9 130 m2 (98,274.5 ft2) of retail commercial and office space, building heights in excess of 34 storeys, and maximum floor space index (FSI) of 4.8 and 7.6 on 6A (north block, Phase 4, Parts 1 and 2) and 6B (south block, Phases 3 and 5), respectively;
  - c. Amend the RA5-42, H-RA5-42, RA5-43 and H-RA5-43 zoning to permit four apartment buildings containing 1,355 units with heights of 32, 35, 35 and 38 storeys.

be approved subject to the conditions referenced in the staff report dated August 14, 2020 from the Commissioner of Planning and Building.

- 2. That the applicant agree to satisfy all the requirements of the City and any other external agency concerned with the development.
- That the "H" holding symbols are to be removed from H-RA5-42 and H-RA5-43 (Apartments) zoning applicable to the subject lands, by further amendment upon confirmation from applicable agencies and City Departments that matters as outlined in the report dated August 14, 2020, from the Commissioner of Planning and Building have been satisfactorily addressed.
- 4. Notwithstanding subsection 45.1.3 of the Planning Act, subsequent to Council approval of the development application, the applicant can apply for a minor variance application, provided that the height and FSI shall not increase.

Dear Mayor Crombie and Councilors,

Sunlight Street, Mississauga, is a busy street in Churchill Meadows, Ward 10. It is a very straight, narrow street that is flanked by Tenth Line West on the east end and Freshwater Drive on the west end. Approximately half way down the street at Trailbank Drive there is a stop sign and the entrance to one of Churchill Meadow's busiest parks, O'Connor Park.

The majority of residences on Sunlight Street house school-aged children. Many of these children walk to McKinnon PS, St. Bernard of Clairvaux CES, and Ruth Thompson Middle School. Many of these children also play on their front lawns, at O'Connor Park and Mississauga Rotary Park (which is located beside McKinnon PS on Tacc Drive).

Although examples of speeding and dangerous driving can be seen on all streets to some degree, the incidents of these problems on Sunlight Street have increased at an alarming rate. Oftentimes these dangerous drivers travel up the street at dangerous speeds and fail to stop at the stop sign at Trailbank Drive, where the entrance to O'Connor Park is located. Peel Police have many times set up at this stop sign due to the many complaints of residents. Furthermore, we have recently learned that an adjacent street, Tacc Drive, will be having speed humps installed. This will increase the traffic on our street as some drivers will seek alternate routes, which will only exacerbate the problems on our street.

The residents of Sunlight Street are fed up with the driving behaviours we are observing on our street. We are afraid for the safety of our families. We need the city to step in and help us protect our children. We, the residents of Sunlight Street, urge City Council to install speed humps along the entire length of Sunlight Street. Of the 101 household on Sunlight Street, 74 have signed the petition.

Pedestrians are being struck at alarming rates in Churchill Meadows. On August 2, 2020, just a few days after the completion of our petition, I personally witnessed a pedestrian get hit by a car at the base of Sunlight Street. Unfortunately for this gentleman, we were unable to protect him. This incident serves as confirmation that something needs to be done to protect the residents on our street. We need the City to take action on our behalf before anyone else is injured, or killed, on our street.

# SUMP PUMP SUBSIDY PROGRAM – ONE-TIME REIMBURSEMENT FOR THE INSTALLATION OF A SECOND SUMP PUMP 7254 BLACK WALNUT TRAIL

WHEREAS the City of Mississauga has established a Foundation Drain Collector (FDC) Sump Pump Subsidy Program (the "Program") to provide financial assistance to all households serviced by a municipal FDC system and wish to install a sump pump as a protection measure against basement water infiltration;

AND WHEREAS under the Foundation Drain Collector (FDC) Sump Pump Subsidy Program By-law 0210-2017 (the "By-law"), the City of Mississauga provides a sump pump subsidy to all households in the City of Mississauga that are serviced by a municipal FDC system and meet the eligibility requirements under the By-law;

AND WHEREAS under subsection 1(b) of the By-law, the maximum contribution by the City of Mississauga, including any prior amounts already provided to a homeowner under the Program, is \$6000 or less (the "Maximum Contribution");

AND WHEREAS the typical contribution by the City of Mississauga to a homeowner for the cost of one sump pump installation under the Program is just under \$6,000;

AND WHEREAS the homeowners at 7254 Black Walnut Trail have, based on City of Mississauga records, reported basement water infiltration three times subsequent to the installation of a sump pump under the Program;

AND WHEREAS 7254 Black Walnut Trail is the only home, based on City of Mississauga records, with multiple reported basement water infiltration occurrences subsequent to the installation of a sump pump;

AND WHEREAS the installation of an additional sump pump may further reduce the risk of basement water infiltration at 7254 Black Walnut Trail;

NOW THEREFORE BE IT RESOLVED THAT in the particular case at 7254 Black Walnut Trail, the Maximum Contribution requirement under the By-law be waived to allow for a one-time approval for the installation of a second sump pump under the City of Mississauga's sump pump subsidy program.
