
A By-law to authorize the execution of a

WHEREAS Lakeview Community Partners Limited has submitted a Section 49.2 Agreement addressing requirements under a Minister’s Order issued under section 49.2 of the *Planning Act*, R.S.O. 1990, c. P.13, dated April 8, 2024, related to their lands municipally known as 1082 Lakeshore Road East and 800 Hydro Road (the “Lakeview Site”);
