John Dunlop, Manager, Heritage Planning & Indigenous Relations provided an update on Indigenous Relations and advised the committee of the City's 3 pillar system which focuses on friendship/protocol, programming/people and planning/resources.

Committee members engaged in discussion and inquired about the City's long term goals for Indigenous Relations. Mr. Dunlop advised that the City is still in the early stages and would be working on ensuring coordination of engagement and consultation actions with Indigenous communities.

RECOMMENDATION DIAC-0006-2020

5.2 <u>Sam Rogers, Director, Enforcement and Alexandra Schwenger, Policy Analyst regarding</u>
the Noise Control By-law Review

Alexandra Schwenger, Policy Analyst provided an update on the Noise Control Program Review with respect to broadcasting audible expressions of faith and spoke to the community engagement, survey results, and key findings. Ms. Schwenger provided the following options to the committee for consideration:

Option 1: Allowing general prohibitions and exemptions

- Option 2: Allowing general prohibitions and not allowing exemptions
- Option 3: Not allowing general prohibitions or exemptions

Sam Rogers, Director, Enforcement advised that staff recommend option 1. Mr. Rogers advised that staff would be seeking funding to consult with an acoustic engineer to complete a decibel study. Mr. Rogers advised that staff would then plan to amend the by-law as the decibel study would supplement the objection process.

Committee Members engaged in discussion and enquired about community feedback and complaints. Mr. Rogers advised no complaints were received with respect to the previous Noise Control By-law exemptions.

RECOMMENDATION DIAC-0007-2020

- 1. That the deputation from Alexandra Schwenger, Policy Analyst and Sam Rogers, Director, Enforcement regarding the Noise Control By-law Review be received;
- That the Diversity and Inclusion Advisory Committee support the proposed amendments to the Noise Control By-law allowing general prohibitions and exemptions with respect to audible expressions of faith and that staff report back to a future General Committee meeting.

6. PUBLIC QUESTION PERIOD - 15 Minute Limit

Sue Shanly, Resident noted that MIRANET had engaged in discussion on Noise Control By-law concerns and advised that all faith based groups should be treated equally. Sam Rogers, Director, Enforcement advised that enforcement staff had been in consultation with legal services staff to ensure that the proposed changes to the Noise Control By-law are in compliance with the Canadian Charter of Rights and Freedoms.

Peter Francis, Resident inquired about the previous Noise Control By-law exemptions. Mr. Rogers advised that the by-law only permits audible sound until 5:00 PM and that the previous exemption requests were to extend the permitted time past 5:00 PM.

Alex Malek, Resident was scheduled to speak during public question period, however he was experiencing technical difficulties and was advised to send his comments directly to staff.

7. MATTERS TO BE CONSIDERED

7.1 Call for Curator for a Community Art Project

Lisa Abbott, Manager, Museums of Mississauga & SAIB advised that Museums of Mississauga was seeking one member of the Diversity and Inclusion Advisory Committee (DIAC) to review proposals and make recommendations for a Community Art Project. Ms. Abbott advised that this project would be intended to provide access to space and resources for a curator or curators who identify as Black, Indigenous, Mixed

Race or Person(s) of Colour. Irfan Malik, Josephine Bau and Brad Bass volunteered to represent DIAC with respect to this project.

The Mayor introduced Sara Alimardani, Senior Stakeholder Relations Advisor. Ms. Alimardani advised that there had been a number of stakeholder conferences with the Peel Regional Police that discussed police reforms, police accountability and body word cameras. Ms. Alimardani advised that the next steps would be to establish the black caucus and noted that outreach was currently taking place. Ms. Alimardani advised that staff would be coming back to the Diversity and Inclusion Advisory Committee (DIAC) to propose amending the DIAC terms of reference to include anti-racism.
