MATTERS CONSIDERED

1. Request to Alter a Heritage Designated Property: Mississauga Road South Right-of-Way (Ward 1)

Members of the Subcommittee engaged in discussion and noted the following questions and concerns regarding the proposed alterations:

- Concerned that the look of the poles would not be in keeping with the Heritage Conservation District Area;
- Concerned about the impact to the trees;
- Concerned about the proposed height of the hydro poles; and
- Inquired about alternatives to the hydro poles such as burying the power lines underground.

Joel Lacombe, Tirath Garcha and Chris Kafel, Alectra Utilities responded to the questions raised by the subcommittee:

- Advised that putting the power lines underground was a possibility, however the
 existing infrastructure underneath the properties would need to be updated;
- Noted that putting the power lines underground would result in a greater impact to the trees in the area; and

• Advised that the proposal of the hydro poles was selected in order to lessen the impact on the Heritage Conservation District Area.

John Dunlop, Manager, Heritage Planning and Indigenous Relations advised that the application met the technical requirements within the Heritage Conservation District Plan. Member of the Subcommittee discussed their options with staff and requested that the applicant withdraw their application as the Subcommittee rejected the current proposal. Members of the Subcommittee noted that more time and consultation with the applicant was needed.

RECOMMENDATION – PCHCD-0002-2020

- That the applicant be requested to withdraw their application regarding the request to alter the heritage designated property, in the Right-of-Way along Mississauga Road South, south of Lakeshore Road West.
- 2. That the request to alter the heritage designated property, in the Right-of-Way along Mississauga Road South, south of Lakeshore Road West, as per the Corporate Report from the Commissioner of Community Services, dated September 8, 2020, be rejected.
