- 5.1 <u>Community Safety and Well-Being Vision Zero PowerPoint Inspector Peter Danos,</u> <u>Peel Regional Police</u>

Inspector Peter Danos, Peel Regional Police presented on the subject matter highlighting the Community Safety and Well-being framework, mobilization/community operations reporting structure, data of fatalities and life altering injuries and cases of bad driving behaviours, "Take the Pledge" social development strategy connecting communities leaders; future goals and milestones, and explained the Regional Situation Table.

In response to Suzanne Doyle's, Mississauga Cycling Advisory Committee Representative, inquiry regarding whether there are differences in referrals for different ages, specifically 16 year old's, Inspector Peter Danos, Peel Regional Police, advised that cases involving age groups under the *Under Offender Act*, would be subject to parental approval.

5.2 <u>Pedestrian Safety Month – Campaign Results, Amy Camara, Communications</u> <u>Coordinator</u>

Amy Camara, Communications Coordinator presented an overview of the performance results of the Pedestrian Safety Month campaign for October 1, 2020 to October 31, 2020, highlighting the communication tactics and messaging for the campaign kick-off, campaign goals, collaboration and partnerships, educational resources and budget allocations.

In response to Councillor Ras' inquiry with respect to provided pedestrian safety messaging all year round and not only during campaigns, Amy Camara, Communications Coordinator advised that continuing partnerships with the Region of Peel, Peel Regional Police and the Ministry of Transportation is key to delivering messaging as well as messaging delivered through other campaigns throughout the year, especially during times when children are returning to school, such as distracted driving and speeds limits.

In response to Councillor Saito's inquiry regarding budget required to continue running social media ads and occasional portable signs, Amy Camara, Communications Coordinator advised that she and the Communications team would have to review advertising costs and report back to the Committee. Councillor Saito recommended that the Promotional Subcommittee meet to discuss budget allocations to extend Pedestrian Safety messaging until the end of January 2021. Karen Flores, Supervisor, Communications Department, advised that the Communications team will meet to review costs associated with continuing messaging and put forward a budget proposal for approval at the Council meeting on November 25, 2020.

5.3 <u>Automated Speed Enforcement (ASE), Samantha Gileno, Senior Communications</u> <u>Advisor</u>

Samantha Gileno, Senior Communications Advisor presented an overview of the Automated Speed Enforcement (ASE), noting that the installation of the camera's will only be in school and community safety zones with speeds less than 80 km/hr, and only after a 90 day notice period has been provided, which may consist of mobile, digital signs and selected print ads. Ms. Gileno, Senior Communications Advisor spoke of the success of the program in Toronto and the installation of the cameras in other jurisdictions in Ontario. Ms. Gileno highlighted the importance of the program in getting drivers to slow down and noted that this program is not the only tool to keep streets safe, and that there are a number of other means guided through Vision Zero to achieve speed compliance, including educating the public through clear and consistent messaging throughout the province.

In response to Councillor Dasko's inquiry with respect to timelines for the program's live date, Colin Patterson, Supervisor, Road Safety, advised that staff will need to ensure that school zone speed limits have been changed and that locations have been vetted for approval of the camera deployment before the 90 day notice is launched, which is expected to be at the beginning of 2021 with the program in operation by the spring.
