Tax Adjustments pursuant to Section 357 and 358 of the Municipal Act

Recommendation

1. That the report of the Commissioner of Corporate Services and Chief Financial Officer dated February 5, 2021 entitled Tax Adjustments pursuant to Section 357 and 358 of the *Municipal Act* be received.
2. That the tax adjustments outlined in Appendix 1 attached to this report for applications for cancellation or refund of taxes pursuant to Sections 357 and 358 of the *Municipal Act* be approved.

Background

Sections 357 and 358 of the *Municipal Act, 2001, S.O. 2001, c.25* allow a property owner or the Treasurer to make an application for the cancellation, reduction or refund of taxes for a number of specific reasons. Taxes may be adjusted when a building has been demolished or razed by fire or if a property has become exempt, changed class or has been overcharged by reason of gross or manifest error.

Comments

A total of 54 applications for tax adjustments have been prepared for Council's consideration.

The total cancellation or refund of taxes as recommended is \$287,303.91. Appendix 1 outlines the tax cancellations being recommended by property and summarizes by reason the number of applications and tax dollars recommended for reduction.

Following Council's decision, a Notice of Decision will be mailed to all applicants and their taxes will be adjusted accordingly. With the exception of Section 358 applications, if the applicant disagrees with the amount of the tax adjustment, they have 35 days from the date of the Notice

of Decision to appeal Council's decision to the Assessment Review Board. Council's decision with respect to Section 358 tax adjustments is final.

Financial Impact

The tax cancellations resulting from the section 357 and 358 applications as listed in Appendix 1 will be charged back as follows:

Dear Mayor Crombie:

Thank you for your letter about safety on Ontario roads and Vision Zero. Please accept my apologies for the delay in responding.

The Ministry of Transportation (MTO) is strongly committed to promoting the highest standards of safety for all Ontarians who travel on our roads -- including drivers, pedestrians and cyclists -- and will continue working with our partners on measures that enhance this objective.

We recognize that a combination of legislative, engineering, enforcement and public education efforts are necessary to achieve desired road user behaviour changes, which is why the government has taken steps to keep vulnerable road users safe:

- Effective September 1, 2018, under the *Cannabis, Smoke-Free Ontario and Road Safety Statute Law Amendment Act, 2017*, new measures came into force designed to better protect vulnerable road users:
 - A new offence for careless driving causing bodily harm and/or death;
 - Increased penalties (fines and demerit points) for motorists and cyclists who fail to yield to pedestrians at crosswalks, crossovers and school crossings.
 - Tougher penalties for distracted driving -- such as using a cell phone while operating a vehicle -- including higher fines, more demerit points, and license suspensions, came into force January 1, 2019.
- Effective July 1, 2018, also under the *Cannabis, Smoke-Free Ontario and Road Safety Statute Law Amendment Act, 2017*, the general penalty fine range in the *Highway Traffic Act* (HTA) was raised so that motorists and cyclists can be held to a higher degree of accountability for all general traffic violations.

- Effective January 1, 2016, under the *Making Ontario's Roads Safer Act, 2015*, drivers and cyclists must stop and yield the entire roadway to pedestrians at pedestrian crossovers, school crossings and all locations where there is a crossing guard.

It is important to note that, with respect to the enforcement of these laws, the police act independently when carrying out their duties. The day-to-day operations of police services and the actions of its officers are the responsibility of the chief of police or his/her representative. As such, individuals concerned about the way that provincial laws are being enforced should contact their local police service directly.

The ministry continues to reinforce the relevant HTA provisions and pedestrian safety through public education activities. We believe strongly that public education is key to road safety for all Ontarians. That is why we continue to provide education to both motorists and pedestrians to promote safe sharing of the road. In this endeavor, the ministry works with police services, injury prevention advocates and community groups.

As you may already know, Ontario is committed to the National Canadian Council of Motor Transport Administrators (CCMTA) Road Safety Strategy 2025 (RSS 2025). RSS 2025 has the long-term vision of Making Canada's roads the safest in the world and sets "Towards Zero" as an aspirational target.

I have asked ministry staff to contact your municipal staff to discuss our respective programs. We are very interested to learn from the experiences of others as a way to continue to improve safety on our highways. Your staff may also be interested in work being undertaken by the Transportation Association of Canada regarding Vision Zero. Part of the initiative will be to review Vision Zero against CCMTA in addition to promoting information exchange related to best practices.

Our government is committed to making sure our roads stay safe and to improve road safety. We will continue to explore additional enforcement and safety measures to ensure the safety of our roadways. Our government will continue to consult and support municipalities in our joined efforts to keep Ontario's roads the safest roads in North America.

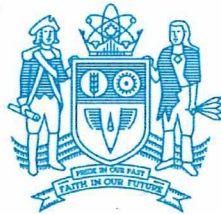

RE: Stakeholder Task Force for a Provincial Vision Zero Strategy

Dear Minister Mulroney,

A loss of life or serious injury from a motor vehicle accident on our road system is one too many. Safety on our City's roads is of primary concern for my Council, especially since these accidents are largely preventable.

In February of 2018 the Mississauga City Council passed Resolution 0045-2018 to adopt a Vision Zero framework. The goal of this program is to prevent serious injuries and fatalities from motor vehicle collisions, diminishing these rates to zero. As part of the framework, Council passed a By-Law to lower speed limits on residential streets from 50 to 40 km/h, thanks to a recent amendment to the provincial Highway Traffic Act. This program has been implemented in 10 neighbourhoods across the City with plans for a full roll-out in the near future.

Mississauga is not alone on its road safety action. Several municipalities across the province have adopted Vision Zero Frameworks including Hamilton, Kingston, London, Toronto, the Region of Peel and Durham Region. Many Canadian provinces have led efforts to coordinate local actions, including British Columbia, Manitoba, Quebec and Saskatchewan.

I write to you on behalf of my Council and our approved Resolution 0289-2019 (see attached) to request you to convene a stakeholder task force group. A task force at the Provincial level would help align efforts, resources and commitments and better coordinate our municipal actions. The function of this group would be to advise the Provincial government on how a Vision Zero strategy can be developed and implemented in Ontario.

For Vision Zero to be a successful endeavour at the local level, leadership of the Province working together with key stakeholder groups, including the Ontario Goods Roads Association are essential.

I look forward to hearing a positive response from you to ensure that we work together to make Mississauga and Ontario roads safer to walk, cycle, play and drive on.

Draft Motion – Gas Fired Electricity Generation Phase Out

WHEREAS the Government of Ontario is planning to increase greenhouse gas (GHG) emissions from Ontario's gas-fired power plants by more than 300% by 2030 and by 500% or more by 2040, reversing more than 40% of the GHG reductions that were achieved by phasing out coal-fired power plants; and

WHEREAS GHG emissions are causing temperatures to rise in Canada at more than double the rate of the rest of the world, causing impacts to municipal operations and affecting City of Mississauga residents; and

WHEREAS, in June 2019, the City of Mississauga declared a climate emergency; and

WHEREAS, in December 2019, the City of Mississauga approved the City's first comprehensive Climate Change Action Plan (CCAP) which sets out ambitious goals, including reducing GHG emissions 80% (as compared to 1990 levels) by 2050; and

WHEREAS, the latest Five Year Energy Conservation Plan (2019-2023) has a target of a 1% reduction per year in energy use and GHG emissions in our facilities, over the next five years; and

WHEREAS, if the City is to meet its targets under the CCAP and the Five Year Energy Conservation Plan (2019-2023), the Ontario electricity grid must remain low carbon; and

WHEREAS the Environmental Action Committee has reviewed the material from the Ontario Clean Air Alliance and supports the request to pass this motion; and

THEREFORE be it resolved that the City of Mississauga requests the Government of Ontario to place an interim cap of 2.5 megatonnes per year on GHG emissions from Ontario's gas-fired power plants and develop and implement a plan to phase-out all gas-fired electricity generation by 2030 to ensure that Ontario meets its climate targets; and

THAT this resolution be sent to the Minister Environment, Conservation, and Parks, the Minister of Energy, Northern Development and Mines, all Mississauga MPPs, and Ontario Premier Doug Ford as proposed by the Ontario Clean Air Alliance.

Motion re Food truck exemption

Whereas the COVID shutdowns have impacted all businesses in the City of Mississauga;

And whereas Council has put in place temporary exemptions and policy changes to help support all businesses; and

Whereas many restaurants in malls have been closed due to the restrictions; and

Whereas mall operators have asked for permission to allow food trucks to operate on their property; and

Whereas By-Law 520-2004 prohibits food trucks from operating within a 500 m distance of restaurants selling the same products; and

Whereas food truck operators have requested exemptions from this restriction during the pandemic.

Therefore be it resolved that Council approve a temporary exemption to the requirement for a 500 metre separation between a full service food truck and a business selling similar products on private property until September 30, 2021 under the following conditions:

1. Written permission from the property owner for the food truck to be on the site
2. A letter of no objection from a majority of similar businesses within the 500 metre (1640 feet) distance.
3. A maximum of 2 food trucks on any property with a minimum distance of 30 metres (100 feet) between each.



WHEREAS on September 16, 2020, City Council adopted Resolution 0297-2020, which included Recommendation PDC0030-2020, which recommended the approval of an application under file OZ/18/011 W5, Pinnacle International (Ontario) Ltd., 0 & 5044 Hurontario Street, west side of Hurontario Street, north of Eglinton Avenue West, to amend certain policies of the Official Plan, and to amend the zoning by-law to permit four apartment buildings containing 1,355 units with height of 32, 35, 35, and 38 storeys;

AND WHEREAS the applicant has requested a revision to condition 1(c) in order to accommodate minor revisions to the proposed 35 storey apartment building located at the northwest corner of Hurontario Street and Watergarden Drive, as well as a revision to Recommendation 3 in order to rezone a portion of the subject lands located at the northwest corner of Hurontario Street and Watergarden Drive without an "H" holding provision in the zoning by-law;

AND WHEREAS the applicant has revised the proposed podium design to incorporate a minimum building height of 1 storey where the podium does not face a public right of way, and a minimum building height of 2 storeys where the podium faces Watergarden Drive;

AND WHEREAS, the "H" holding provision would require the applicant to enter into an agreement for the provision for public art;

AND WHEREAS, the agreement for public art has been executed by the applicant and City of Mississauga, thereby negating the need for an "H" holding provision in the RA5-43 zone;

AND WHEREAS these proposed changes have been reviewed by the Planning and Building Department and staff have no concerns with the proposed revisions and consider the changes to be minor in nature;

AND WHEREAS notwithstanding that subsequent to the Public Meetings held on February 19, 2019 and September 8, 2020, minor changes to the rezoning application has been made, Council considers that the changes do not require further notice, and therefore pursuant to the provisions of subsection 34(17) of the *Planning Act*, R.S.O. 1990, c.P.13, as amended, any further notice regarding the application is hereby waived;

NOW THEREFORE LET IT BE RESOLVED

That Recommendation 1(c) and Recommendation 3 as part of Recommendation Resolution 0030-2020 be amended by deleting the original and replacing it with the following:

- 1(c) Amend the RA5-42 and H-RA5-42 zoning to permit three apartment buildings with heights of 32, 35, and 38 storeys, and amend the RA5-43 and to permit one apartment building with a height of 35 storeys atop a podium of varying heights ranging from 1 storey to 6 storeys, to permit a total of 1,355 units.

3. That the "H" holding symbol is to be removed from H-RA5-42 (Apartments) zoning applicable to the subject lands, by further amendment upon confirmation from applicable agencies and City Departments that matters as outlined in the report dated August 14, 2020, from the Commissioner of Planning and Building have been satisfactorily addressed.

That conditions 1a, 1b, 2, and 4 remain as approved.
