### **Consolidated Recommendation**

The City recommends that the Committee have regard for all comments and evidence provided by the applicant and area residents when assessing if the application meets the requirements of Section 45 (1) of the Planning Act.

# **Application Details**

The applicants request the Committee to approve a minor variance to allow the construction of an addition on the subject property proposing a combined width of side yards of 6.83m (approx. 22.41ft) whereas By-law 0225-2007, as amended, requires a minimum combined width of side yards of 7.40m (approx. 24.28ft) in this instance.



#### **Site and Area Context**

The subject property is located within the Clarkson-Lorne Park Neighbourhood Character Area, southwest of Lorne Park Road and Lakeshore Road West. The neighbourhood is entirely residential consisting of one and two storey detached dwellings with significant mature vegetation. The subject property contains an existing two storey dwelling with mature vegetation and abuts Jack Darling Memorial Park to the rear.

The application proposes a one storey rear addition, requiring a variance related to a deficient combined side yard width.



### Comments

#### **Planning**

Section 45 of the *Planning Act* provides the Committee of Adjustment with the authority to grant relief from the requirements of a municipal zoning by-law. Approval of applications must meet the requirements set out under 45(1) and/or 45(2) (a) or (b) in the *Planning Act*.

Staff comments concerning the application request are as follows:

The proposed variance represents an existing deficiency that will not significantly impact neighbouring properties as a result of the increased massing. The proposed rear addition is limited to one storey, minimizing the impact to the neighbouring property. As such, staff is of the

opinion that the application is appropriate to be handled through the minor variance process. Further, the application raises no concerns of a planning nature.
