Consolidated Recommendation

The City recommends that the Committee have regard for all comments and evidence provided by the Applicant and area residents when assessing if the application, as requested, meets the requirements of Section 45(1) of the Planning Act.

Application Details

The applicant requests the approval of the Committee to sever a parcel of land for the creation of a new lot. The parcel of land has a frontage of approximately 7.62m (25.00ft) and an area of approximately 278.60sq.m (2998.83sq.ft).

A minor variance is requested for the Retained Lands (A138/21) proposing:

- 1. A lot coverage of 49.85% whereas By-law 0225-2007, as amended, permits a maximum lot coverage of 45.00% in this instance; and
- 2. A building height measured to the highest ridge of 10.02m (approx. 32.87ft) whereas Bylaw 0225-2007, as amended, permits a maximum building height measured to the roof of 9.50m (approx. 31.17ft) in this instance.

A minor variance is requested for the Severed Lands (A139/21) proposing:

- 1. A lot coverage of 49.85% whereas By-law 0225-2007, as amended, permits a maximum lot coverage of 45.00% in this instance; and
- 2. A building height measured to the highest ridge of 10.02m (approx. 32.87ft) whereas Bylaw 0225-2007, as amended, permits a maximum building height measured to the roof of 9.50m (approx. 31.17ft) in this instance.

Site and Area Context

The subject property is located within the Port Credit Neighbourhood Character Area, north of Lakeshore Road West and Mississauga Road North. The surrounding area contains an eclectic mix of uses including commercial, high-rise residential, a retirement building and different forms of low density residential. The subject property contains an existing one storey detached dwelling with mature vegetation in the rear yard.

The applicant is proposing to sever the existing lot for the purpose of developing semi-detached dwellings that require variances related to lot coverage and height.

Planning

Planning Act

Section 51 (24) of the *Planning Act* sets out the criteria for land division in the Province of Ontario. In evaluating such requests, the Committee needs to be satisfied that the proposal meets not only the criteria set out under Section 51(24), but also municipal requirements identify in local legislation.

Section 45 of the *Planning Act* provides the Committee of Adjustment with the authority to grant relief from the requirements of a municipal zoning by-law. In evaluating such requests, the Committee needs to be satisfied that the proposal meets the four tests set out in the *Planning Act*.

Provincial Matters

The Provincial Policy Statement 2014 (PPS 2014) and Growth Plan for the Greater Golden Horseshoe promote efficient development and land use, directing the focus towards intensification and redevelopment. The proposal is consistent with the general directive in provincial policy.

Staff comments concerning the applications are as follows:

The subject property is designated Residential Low Density II in Schedule 10 of the Mississauga Official Plan (MOP) which permits detached, semi-detached, duplex, triplex and other forms of low rise dwellings with individual frontages. The above noted applications were initially heard and deferred by the Committee of Adjustment on April 29th, 2021. Planning staff supported the applicant's proposed severance plan in their report dated April 21st, 2021. However, Staff recommended deferral of the applications to address the proposed overall and eave height variances. Staff is still supportive of the proposed severance, as the proposal remains the same.

Variance #1 for the severed and retained lands pertains to lot coverage. Staff comments with respect to lot coverage are contained in their report dated April 21, 2021.

Variance #2 for the severed and retained lands pertains to building height. The applicant proposes a building height measured to the highest ridge of 10.02m (32.87ft) where a maximum building height measured to the roof of 9.50m (31.17ft) is permitted. The intent of restricting height to the highest ridge is to lessen the visual massing of dwelling and bring the edge of the roof closer to the ground, thereby keeping the dwelling within a human scale. Staff note that there is a 0.11m (0.36ft) discrepancy between average and established grade. From a streetscape perspective, the proposed height would be 9.91m (32.51ft), which would represent a minor deviation from the maximum permitted in the zoning by-law. Furthermore, by incorporating the second storey in the roof structure, the proposed architectural design feature

minimizes the overall height and massing impact of the proposed dwelling. As such, the proposed dwelling maintains compatibility with the surrounding area and would not negatively impact the character streetscape.

Staff is of the opinion that the general intent and purpose of the zoning by-law is maintained.

The proposed dwelling include architectural features, such as dormers set vertically on the proposed roof and grey composite panels which help define the entryway and break up the overall massing and height of the dwelling. Additionally, the proposal is consistent with newer two storey semi-detached dwellings within the immediate area and does not pose a negative impact to the streetscape character.

Appendix 1 – Transportation and Works Comments

Should Committee see merit in the applicant's request we are providing the following conditions/requirements for Committee's consideration:

A. Items Required Prior to the Issuance of Final Consent

1. Overall Grading and Drainage Plan

The applicant's consulting engineer will be required to prepare an Overall Grading and Drainage Plan which contains sufficient details to ensure grading compatibility with the adjacent lands and submit the grading and drainage proposal to this department for review/approval.

2. Municipal Address Requirement

Prior to the issuance of final consent, satisfactory arrangements are to be made with Corporate Services Department, Information Technology Division, Digital Services & Mobility Section, Geospatial Solutions Group for the creation of new municipal addresses for the severed and retained lands. 3. Dedication of Mississauga Road Widening

The Owner will be required to gratuitously dedicate a road allowance widening towards the ultimate 26.0m right of way for Mississauga Road to the City of Mississauga as identified in the Official Plan. The applicant's surveyor is to prepare and submit two draft reference plans (detailing the required lands) to this section for review and approval. Following this approval, the applicant's surveyor should deposit the accepted draft reference plan and forward a copy of the registered plan to the City's Legal Services Section to finalize the process. This condition will be cleared upon receipt of confirmation from Legal Services identifying that the transfer has taken place and associated fees have been paid.

The dimensions related to right-of-way widths and required widenings are to be verified by the City's O.L.S., Al Jeraj at 905-615-3200 ext. 5789.

В. **GENERAL INFORMATION**

1. Lot Grading and Drainage

We advise the applicant that issuance of any building permits for the new dwelling(s) will be subject to the owner submitting a certified lot grading and drainage plan to this Department for review/approval. The grading and drainage plan is to contain sufficient detail to ensure grading compatibility with the adjacent properties. In addition, the owner will be required to submit the applicable lot grading and municipal services protection deposits.

2. Servicing

All costs incurred in providing any service laterals will be the responsibility of the owner. The owner will also be responsible for all costs incurred for the required road reinstatement (if required). If the service connections are to be installed by a private contractor retained by the owner, issuance of an open cut permit will be subject to the owner depositing adequate securities with the City to guarantee proper road reinstatement.

3. <u>Access</u>

We advise the applicant that all costs incurred in providing any new driveway entrance(s) to the subject lands or any modifications/reinstatement required, would be at cost to the owner. The applicant will be required to apply for Access Modification Permits prior to Site Plan Approval and/or Building Permit Issuance. We are also noting that should any utilities need to be relocated, all costs incurred will also be to the owner.

4. Storm Sewer Outlet

The storm sewer outlet for this property is the existing 375m Dia. Storm sewer located on Mississauga Road North. Please note that a rear lot catch basin may be required. Where

existing sewer capacity exists, applicants are encouraged to design the basement elevation to be at least 1.0 meter above the elevation of the on-street storm sewer obvert to eliminate the need for a sump pump. In situations where a sump pump is required and where a high groundwater table may exist, the sump pump may run continuously. The applicants are encouraged to design the weeping tile elevation to be at least 1.0 meter above the seasonal groundwater elevation. The owner is advised that the City has no obligations to address any concerns related to the operation of private sump pump systems.
