

COMMITTEE OF ADJUSTMENT NOTICE OF PUBLIC HEARING

Why you received this letter:

You are receiving this letter because you are the owner of a neighbouring property within 60m (200ft) of the subject property, or are the agent/interested party/owner of the property for the application.

Details of the application and meeting information:

The property owner of 1440 Watersedge Road, zoned R1-2- Residential, has applied for a minor variance under Section 45 of the Planning Act. The applicant requests the Committee to approve a minor variance to allow the construction of an addition proposing:

1. A gross floor area of 517.55sq.m (approx. 5,570.86sq.ft) whereas By-law 0225-2007, as amended, permits a maximum gross floor area of 473.09sq.m (approx. 5,092.30ft) in this instance;

2. A combined width of side yards (existing) of 6.13m (approx. 20.11ft) whereas By-law 0225-2007, as amended, requires a minimum combined width of side yards of 8.23m (approx. 27.00ft) in this instance;

3. A side yard setback to the second floor of 1.77m (approx. 5.81ft) whereas By-law 0225-2007, as amended, requires a minimum side yard setback of 2.41m (approx. 7.91ft) in this instance;

4. A side yard setback (existing) to the exterior staircase of 0.97m (approx. 3.18ft) whereas By-law 0225-2007, as amended, requires a minimum side yard setback of 1.20m (approx. 3.94ft) in this instance;

5. A lot coverage of 25.5% whereas By-law 0225-2007, as amended, permits a maximum lot coverage of 25.0% in this instance;

6. A height of eaves of 7.55m (approx. 24.77ft) measured from average grade to lower edge of the eaves whereas By-law 0225-2007, as amended, permits a maximum height of eaves of 6.40m (approx. 21.00ft) measured from average grade to lower edge of the eaves in this instance;

7. A driveway width (existing) of 10.38m (approx. 35.06ft) whereas By-law 0225-2007, as amended, permits a maximum driveway width of 8.50m (approx. 27.89ft) in this instance; and

8. A walkway width (existing) of 3.80m (approx. 12.47ft) attached to the driveway whereas By-law 0225-2007, as amended, permits a maximum walkway width of 1.50m (approx. 4.92ft) attached to a driveway in this instance.

The Committee has set **Thursday January 13, 2022** at **3:00 pm** for the public hearing on this matter. As a result of COVID-19 restrictions and under the authority of the *Municipal Act, Emergency Management and Civil Protection Act* and *Statutory Powers Procedure Act*, City Council approved Committee of Adjustment hearings to be held electronically during an Emergency. All items on the agenda are scheduled for 1:00 pm and will be heard in the order shown on the agenda.
