

COMMITTEE OF ADJUSTMENT NOTICE OF APPLICATION

Why you received this letter:

You are receiving this letter because you are the owner of a neighbouring property within 60m (200ft) of the subject property, or are the agent/interested party/owner of the property for the application.

Details of the application and meeting information:

The property owner of 698 Montbeck Crescent, zoned R3-75 - Residential, has applied for Consent under Section 53 of the Planning Act. The applicant requests the approval of the Committee to sever a parcel of land for the creation of a new lot. The parcel of land has a frontage of approximately 10.07m (33.04ft) and an area of approximately 433.7sq.m (4,668.31sq.ft).

The applicant requests the Committee to approve a minor variance to allow the construction of a new dwelling on the subject lands, being the retained lands of application B18/22, proposing:

1. A lot frontage of 10.07m (approx. 33.04ft) whereas By-law 0225-2007, as amended, requires a minimum lot frontage of 15.00m (approx. 49.21ft) in this instance;

2. A lot area of 442.5sq.m (approx. 4,763.0sq.ft) whereas By-law 0225-2007, as amended, requires a minimum lot area of 550.0sq.m (approx. 5,920.2sq.ft) in this instance;

3. A lot coverage of 44.25% whereas By-law 0225-2007, as amended, permits a maximum lot coverage of 35.00% in this instance; and,

4. A side yard setback (westerly) of 0.61m (approx. 2.00ft) whereas By-law 0225-2007, as amended, requires a minimum side yard setback of 1.81m (approx. 5.94ft) in this instance.

The applicant requests the Committee to approve a minor variance to allow the construction of a new dwelling on the subject property, being the severed lands of application B18/22, proposing:

1. A lot frontage of 10.07m (approx. 33.04ft) whereas By-law 0225-2007, as amended, requires a minimum lot frontage of 15.00m (approx. 49.21ft) in this instance;

2. A lot area of 433.7sq.m (approx. 4,668.31sq.ft) whereas By-law 0225-2007, as amended, requires a minimum lot area of 550.0sq.m (approx. 5,920.2sq.ft) in this instance;

3. A lot coverage of 44.81% whereas By-law 0225-2007, as amended, permits a maximum lot coverage of 35.00% in this instance;

4. A side yard setback (easterly) of 0.61m (approx. 2.00ft) whereas By-law 0225-2007, as amended, requires a minimum side yard setback of 1.81m (approx. 5.94ft) in this instance; and,

5. A height measured to the underside of eaves of 6.58m (approx. 21.59ft) whereas By-law 0225-2007, as amended, permits a maximum height measured to the underside of eaves of 6.40m (approx. 21.00ft) in this instance.

The Committee has set **Thursday, March 24, 2022** at **1:00 PM** for the public hearing on this matter. As a result of COVID-19 restrictions and under the authority of the *Municipal Act, Emergency Management and Civil Protection Act* and *Statutory Powers Procedure Act*, City Council approved Committee of Adjustment hearings to be held electronically during an Emergency. All items on the agenda are scheduled for 1:00 pm and will be heard in the order shown on the agenda.
