Re: Clarkson Village BIA Boundary Expansion

The Board of Directors of the Clarkson Village BIA would like to respectfully request a boundary expansion.

Accordingly, on February 8, 2022, at its regular board meeting, the Clarkson Village BIA Board of Directors unanimously passed a motion to initiate the boundary expansion process with the City of Mississauga for the following areas:

- West on Lakeshore Road West to 2175 Royal Windsor Drive (includes the Clarkson Crossing shopping area on the south side, and as far as the GO Station entrance on the north side).
- East on Lakeshore Road West to 1400 Lakeshore Road West (includes the plaza at Lakeshore Road West & Johnson's Lane as well as the plaza at Lakeshore Road West & Silver Birch Trail).
- South on Southdown Road to 606 Southdown Road (includes the Clarkson Village Shoppes plaza).
- North on Southdown Road to Truscott Drive (includes the plaza at Southdown Road & Truscott Drive).
- North on Clarkson Road North to the rail line.
- 972 Clarkson Road South and 964 Meadow Wood Road, which are both directly adjacent to the current BIA boundary.

The Clarkson Village Business Improvement Area (BIA) was established in 1989. In the ensuing years the area around the BIA has changed a great deal, however, the BIA boundaries have not. Many businesses in the proposed expansion areas include Clarkson or Clarkson Village in their name, and are already perceived by the public to be part of the BIA. The Board of Directors would like to see property and business owners come together in a formalized way to promote the business area as a whole.

We note that the Municipal Act 2001 outlines the boundary expansion process, and we are fully committed to working through all requirements.






