

Why you received this letter:

You are receiving this letter because you are the owner of a neighbouring property within 60m (200ft) of the subject property, or are the agent/interested party/owner of the property for the application.

Details of the application and meeting information:

The property owner of 10 Broadview Avenue, zoned RM7-5 - Residential, has applied for Consent under Section 53 of the Planning Act. The applicant requests the approval of the Committee to sever a parcel of land for the creation of a new lot. The parcel of land has a frontage of approximately 10.90m (approx. 35.76ft) and an area of approximately 440.4sq.m (approx. 4,740.4sq.ft).

The applicant requests the Committee to approve a minor variance to allow the construction of a new dwelling on the subject property, being the retained lands of application B16/22, proposing:

1. A lot area of 478.30sq.m (approx. 5,148.39sq.ft) whereas By-law 0115-2007, as amended, requires a minimum lot area of 460.00sq.m (approx. 4,951.40sq.ft) in this instance;
2. A lot frontage of 10.67m (approx. 35.00ft) whereas By-law 0115-2007, as amended, requires a minimum lot area of 12.00m (approx. 39.37ft) in this instance;
3. A side yard setback (westerly) of 1.66m (approx. 5.45ft) whereas By-law 0115-2007, as amended, requires a minimum side yard setback of 3.00m (approx. 9.84ft) in this instance; and,
4. A building height of 7.88m (approx. 25.85ft) whereas By-law 0115-2007, as amended, permits a maximum building height of 7.50m (approx. 24.61ft) in this instance.

The applicant requests the Committee to approve a minor variance to allow the construction of a new dwelling on the subject property, being the severed lands of application B16/22, proposing:

1. A lot area of 440.33.m (approx. 4,739.67sq.ft) whereas By-law 0115-2007, as amended, requires a minimum lot area of 460.00sq.m (approx. 4,951.40sq.ft) in this instance;
2. A lot frontage of 10.90m (approx. 35.76ft) whereas By-law 0115-2007, as amended, requires a minimum lot area of 12.00m (approx. 39.37ft) in this instance;
3. A side yard setback (easterly) of 1.93m (approx. 6.33ft) whereas By-law 0115-2007, as amended, requires a minimum side yard setback of 3.00m (approx. 9.84ft) in this instance; and,
4. A building height of 8.0m (approx. 26.25ft) whereas By-law 0115-2007, as amended, permits a maximum building height of 7.5m (approx. 24.61ft) in this instance.

The Committee has set **Thursday, April 7, 2022 at 1:00 PM** for the public hearing on this matter. As a result of COVID-19 restrictions and under the authority of the *Municipal Act, Emergency Management and Civil Protection Act* and *Statutory Powers Procedure Act*, City Council approved Committee of Adjustment hearings to be held electronically during an Emergency. All items on the agenda are scheduled for 1:00 pm and will be heard in the order shown on the agenda.
