Subject: 2022 Quarterly Cycling Program Update (Q2)


The City of Mississauga has an annual cycling program for the installation of cycling infrastructure by the Transportation and Works (T&W) department (along street rights-of-way) and the Community Services (CMS) department (outside of street rights-of-way). The Cycling Program is consistent with the 2018 Cycling Master Plan.

27.6 kilometres of new cycling infrastructure are currently in various stages of development and intended to be constructed by T&W beginning in 2022. Funding for these projects generally comes from existing committed budgets and grants from senior levels of government. Final costs for any project are established once a design is finalized, prior to projects being tendered for bid. 11.7 kilometres of these projects have been tendered and awarded already, while 15.9 kilometres are confirmed to be tendered in 2022. As part of the 2020 COVID-19 Recovery Framework projects, T&W proposed to construct 17.9 km of new cycling infrastructure. 4.3 km of the originally proposed "interim" infrastructure has been deferred, and the "ultimate" design is proposed for a future year's capital program.

The Community Services department have 9.5 km of off-road trails identified in its current capital program. The Region of Peel currently has an intersection improvement planned for construction in 2022.

Cycling infrastructure is being implemented with ongoing capital funding from the City of Mississauga and Region of Peel. The City of Mississauga has also been approved for funding through the Investing in Canada Infrastructure Program - Public Transit Stream and Resilience Stream.

Note that the nature and schedule of the projects listed here are subject to change in accordance with budget, engineering and construction constraints, public consultation and Council approval. All lengths are shown in kilometres, measured along the road centreline (except for off-road trails), from the centre of intersections. Actual paved surface length may differ.

#### **APPENDIX A: Project Status Definitions**

Planning & Design – The project scope and design elements are being developed. This phase includes site assessments, public and internal engagement, conceptual design creation, detailed design creation, traffic analysis, and project feasibility assessments.

Design Complete - The project scope and detailed design are finalized.

Scheduled – The construction contract has been awarded. The construction start date is scheduled.

*Under Construction* – The project is actively being constructed.

Complete – The project is substantially completed and open to the public for use. All regulatory signage (example: reserved bicycle lane signage, shared path signage, cyclist dismount signage) and markings (example: crossrides, bicycle and diamond stencil) have been installed. Non-regulatory signage (example: wayfinding signage) and markings (example: trail centre line) may be pending.

On Hold – The project is on hold but still scheduled for the program year.

*Deferred* – The project has been postponed to a later program year.

Cancelled – The project will no longer take place.
