


Green Development Standards

Background

- The City's Green Development Standard (GDS) was developed in 2012
- The GDS has been the tool through which the P&B promotes environmentally-friendly development
- This voluntary guideline has advanced green buildings and more sustainable sites, such as 98 LEED buildings, 265 bio-swales, 331 permeable areas, 50 rain harvest areas and many other green features.



Climate Change Action Plan



GC endorsed Climate Change Action Plan in 2019

Action #3: Improve the Energy Efficiency and Climate Resilience of New Buildings

The City will work to advance the sustainability and resilience of new private developments to encourage the use of renewable and district energy, reduce stormwater runoff, protect and enhance ecological functions, and reduce urban heat island.

Consultant

- In fall of 2021 an RFP was issued
 no submissions received.
- SSC SUSTAINABILITY SOLUTIONS GROUP
- In 2022 a revised RFP was issued
- 4 bids submitted, finalizing selected consultant April to May 2022

 - Depth of experience, Toronto, Hamilton, Edmonton, Peel Region, Burlington, etc.
 - Recent APA awards for SSG, Toronto and Edmonton Plans



Project Timeline – Six Phases

Phase 1 – Benchmarking/information gathering (June to Sept.)

Phase 2 - 1st. Stakeholder Engagement (Sept.)

Phase 3 - Revised Draft GDS (Oct. to Jan. 2023)

Phase 4 - 2nd. Stakeholder Engagement (Feb. 2023)

Phase 5 - Revised Draft GDS (March to May 2023)

Phase 6 - Final Standards (June 2023)
