1. <u>CALL TO ORDER</u>

Councillor Carlson (Vice-Chair) called the meeting to order at 9:36 AM.

7. DEPUTATIONS

7.1 <u>Michael Foley, Director, Enforcement with respect to Towing and Storage Safety and</u> Enforcement Act (TSSEA) Regulations

Michael Foley, Director, Enforcement provided an overview of the Towing and Storage Safety and Enforcement Act (TSSEA) Regulations which were announced by the Province in June 2020.

Councillor Parrish expressed concerns that the timelines for submitting comments and/or concerns to the Province is April 1, 2022 and that she would be requesting that a Mayor's letter be sent to the Province requesting an extension to submit comments and/or concerns. Councillor Parrish further expressed concern with the language referenced in the Regulations and no mention of dispute resolution or appeal process.

In response to Councillor Parrish's inquiry regarding who will be enforcing the Regulations, and if not City staff, how many City staff jobs would be lost, Mr. Foley, Director, Enforcement advised that at this time it is not clear who the Province will assign the enforcement of the Regulations, only that it will not be Municipal staff; and that based on the revenue models a total of 3 to 5 jobs would be effected.

Councillor Parrish inquired whether Mississauga towing companies have been excluded from providing towing services on the 400 series highway due to the Provincial Pilot Project.

Mr. Foley, Director, Enforcement noted that there are some Mississauga towing companies that were awarded a contract under the Provincial Pilot Project.

John Lyons, Citizen Member noted that the Province awarded contracts to participate in the Provincial Pilot Project without going through a tender process and does not believe that any of the contracts awarded went to Mississauga towing companies. Mr. Lyons explained the challenges of providing towing services to customers who request their services at an accident scene on a 400 series highway.

Councillor Parrish requested staff provide her the details of Provincial Pilot Project operations within the week.

Members of the Towing Advisory Committee raised the following questions/concerns/comments:

- vehicles involved in accidents on the 400 series highways are being towed out of the City of Mississauga
- towing rates under the Provincial Pilot Project are much higher than those regulated in the City of Mississauga
- extend an invitation to a representative from the Province to meet with the Committee
- is there an option for the City of Mississauga and other jurisdictions to maintain their licensing operations
- is there any data available on success/operations of the Provincial Pilot Project

Michael Foley, Director, Enforcement responded as follows:

- a towing company awarded a Provincial Pilot Project contract was required to have a storage facility and that to his knowledge only one company was permitted to use a storage facility outside of the city, but within the Region, due to City of Mississauga's moratorium on pound facilities
- the Provincial Pilot Project towing rates were set by the Province
- he would inquiry if someone from the MTO or the proposed towing group would be available
- the option of multi-tier licensing was addressed; however, the industry and insurance companies opposed the concept of multi-tier licensing
- there has been some communication made available; however, staff will reach out to see if there is any data on traffic flow and response times for arriving at the scene of an accident

8. PUBLIC QUESTION PERIOD - 15 Minute Limit

Todd Keely, Owner and Operator, TLK Towing spoke to the Provincial Pilot Project and the impact it has had on his towing company with the loss of revenue as a result of not being permitted to provide towing services on the 400 series highways and inquired on what the City can do to assist the towing industry in the City of Mississauga.

Robert Flunney, Citizen Member suggested that the staff reach out the Province and invite them to meet with the committee to address their concerns.

Michael Foley, Director, Enforcement advised that anyone can submit comments and/or suggestions directly to the Province. Mr. Foley noted that he does not believe that the Province has established the department and have not yet posted the position for the Director of Enforcement. Mr. Foley advised that he could reach out to the Consultants; however, they would only be able to address the consultation process.
