APPLICATION DETAILS

The applicants request the Committee to approve a minor variance to allow a circular driveway on the subject property proposing a combined width of access points of 9.89m (approx. 32.45ft) whereas By-law 0225-2007, as amended, permits a maximum combined width of access points of 8.50m (approx. 27.88ft) in this instance.

N. Porco, agent, attended and presented evidence and comment in support of the application.

APPLICATION APPROVED AS AMENDED SUBJECT TO CONDITION(S):

To allow a circular driveway and walkway attachments on the subject property proposing:

- 1. A combined width of access points of a circular driveway of 9.89m whereas By-law 0225-2007, as amended, permits a maximum combined width of access points of a circular driveway of 8.50m in this instance;
- 2. A walkway attachment of 2.59m whereas By-law 0225-2007, as amended, permits a maximum walkway attachment of 1.50m in this instance;
- 3. A walkway attachment of 2.18m whereas By-law 0225-2007, as amended, permits a maximum walkway attachment of 1.50m in this istance;
- 4. A walkway attachment of 1.77m whereas By-law 0225-2007, as amended, permits a maximum walkway attachment of 1.50m in this instance; and
- 5. Three walkway attachments attached to a driveway, whereas By-law 0225-2007, as amended, permits one walkway attachment attached to a driveway in this instance.

CONDITION(S):

1. Construction related to this variance shall be in general conformance with the site plan approved by the Committee.
