Consolidated Recommendation

The City recommends that the application be deferred.

Application Details

The applicant requests the Committee to approve a minor variance to allow the construction of a new dwelling proposing:

- 1. A gross floor area of 477.1sqm (approx. 5,135.46sq.ft) whereas By-law 0225-2007, as amended, permits a maximum gross floor area of 408.26sq.m (approx. 4,394.47sq.ft) in this instance;
- 2. A lot coverage of 30.3% whereas By-law 0225-2007, as amended, permits a maximum lot coverage of 30.0% in this instance;
- 3. An eaves height of 7.47m (approx. 24.51ft) whereas By-law 0225-2007, as amended, permits a maximum eaves height of 6.40m (approx. 21.00ft) in this instance;
- 4. A combined width of side yards of 6.15m (approx. 20.18ft) whereas By-law 0225-2007, as amended, requires a minimum combined width of side yards of 6.96m (approx. 22.83ft) in this instance.

Site and Area Context

The subject property is located in the Mineola Neighbourhood Character Area, northwest of the Mineola Road West and Hurontario Street intersection. The immediate neighbourhood primarily consists of a mix of older and newer one and two-storey detached dwellings on large lots with mature vegetation in the front yards. The subject property contains a two-storey detached dwelling with mature vegetation in the front yard.

The application proposes to construct a new detached dwelling requiring variances related to gross floor area, lot coverage, eave height and combined width of side yards.



Comments

Planning

Section 45 of the *Planning Act* provides the Committee of Adjustment with the authority to grant relief from the requirements of a municipal zoning by-law. Approval of applications must meet the requirements set out under 45(1) and/or 45(2) (a) or (b) in the *Planning Act*.

Staff comments concerning the application are as follows:

The subject property is designated Residential Low Density I on Schedule 10 of the Mississauga Official Plan (MOP).

Upon the review of a new two storey-detached dwellings in the neighbourhood, staff are of the opinion that the proposed gross floor area for the dwelling is excessive and does not maintain compatibility between the existing dwellings on the street; nor would it preserve the established character of the neighbourhood. Furthermore, the proposed dwelling contains a significant open to below space at the rear. While this does not contribute to the gross floor area of the dwelling, it contributes to the dwelling's overall massing, which will directly impact the neighbouring properties.

Staff have no immediate concerns with the remaining variances, as requested. Planning staff recommend the application be deferred to give the applicant an opportunity to redesign the dwelling.
