### **Consolidated Recommendation**

The City recommends the application be deferred.

# **Application Details**

The applicant requests the Committee to approve a minor variance to allow an existing driveway with a driveway width of 7.2m (approx. 23.6ft) whereas By-law 0225-2007, as amended, permits a maximum driveway width of 6.0m (approx. 19.7ft) in this instance.

## **Background**

**Property Address:** 6360 Osprey Blvd

**Site and Area Context** 

The subject property is located north-west of the Tenth Line West and Britannia Road West intersection in the Lisgar Neighbourhood. The property contains a two-storey detached dwelling with an attached two car garage and has a lot frontage of +/- 12.41m (40.72ft). The surrounding

context consists of detached and semi-detached dwellings with attached garages. The property contains limited vegetative and landscaping elements.

The applicant is proposing to maintain the existing driveway requiring a variance for driveway width.



### Comments

#### **Planning**

Section 45 of the *Planning Act* provides the Committee of Adjustment with the authority to grant relief from the requirements of a municipal zoning by-law. Approval of applications must meet the requirements set out under 45(1) and/or 45(2) (a) or (b) in the *Planning Act*.

Staff comments concerning the application are as follows:

The subject property is located in the Lisgar Neighbourhood Character Area and is designated Residential Low Density II in Schedule 10 of the Mississauga Official Plan (MOP). Section 9 of MOP promotes development with appropriate urban form and site design, regulating that such development is compatible with: the existing site conditions, the surrounding context, and the landscape of the character area.

The applicant is proposing a driveway width of 7.2m (23.62ft). The planned character of the area is that of residential dwellings serviced by appropriately sized driveways that can accommodate the parking required by the zoning by-law for each property. The intent of the driveway width regulations in the by-law is to allow a driveway that can accommodate two vehicles parked side by side, with the remainder of the front yard being soft landscaped area. The subject property has a frontage of +/- 12.41m (40.72ft), and the proposed driveway would represent more than 50% of the front yard area which is out of character for the surrounding context.


Staff are of the opinion that, as currently proposed, the driveway does not meet the general intent or purpose of the zoning by-law and is not minor in nature. Staff recommend that the application be deferred to allow the applicant to reduce the size of the driveway.

#### **Appendix 2 – Zoning Comments**

In the absence of a development application we are unable to confirm the accuracy of the information provided, or determine whether additional variance(s) may be required. It should be noted that a zoning review has NOT been completed. The applicant is advised that should they choose to proceed without zoning verification, a full zoning review may result in further variances being required in the future.

For scope of work that does not require Site Plan Approval/Building Permit/Certificate of

Occupancy, the applicant may consider applying for a preliminary zoning review application. A detailed site plan drawing and architectural plans are required for a detailed zoning review to be completed. A minimum of 6-8 weeks is required depending on the complexity of the proposal and the quality of information submitted.
