



## COMMITTEE OF ADJUSTMENT NOTICE OF PUBLIC HEARING

### Why you received this letter:

You are receiving this letter because you are the owner of a neighbouring property within 60m (200ft) of the subject property, or are the agent/interested party/owner of the property for the application.

### Details of the application and meeting information:

The property owner of 396 Atwater Ave, zoned R3-1 - Residential, has applied for a minor variance under Section 45 of the Planning Act. The applicant requests the Committee to approve a minor variance application to permit the construction of an addition to an existing dwelling proposing:

1. A front yard setback to the second storey of 6.54m (approx. 21.46ft) whereas By-law 0225-2007, as amended, requires a front yard setback to the second storey of 7.5m (approx. 24.61ft) in this instance;
2. A front yard setback to the second storey eaves overhang of 6.24m (approx. 20.47ft) whereas By-law 0225-2007, as amended, requires a front yard setback to the second storey eaves overhang of 7.05m (approx. 23.13ft) in this instance;
3. Combined side yard widths of 22.12% or 5.73m (approx. 18.80ft) whereas By-law 0225-2007, as amended, requires combined side yard widths of 27% or 7.00m (approx. 23.00ft) in this instance; and,
4. A height to the eaves overhang of 6.52m (approx. 21.39ft) whereas By-law 0225-2007, as amended, permits a maximum height to the eaves overhang of 6.40m (approx. 21.00ft) in this instance.

The Committee has set **Thursday, September 1, 2022 at 1:00 PM** for the public hearing on this matter. As a result of COVID-19 restrictions and under the authority of the *Municipal Act, Emergency Management and Civil Protection Act* and *Statutory Powers Procedure Act*, City Council approved Committee of Adjustment hearings to be held electronically during an Emergency. All items on the agenda are scheduled for 1:00 pm and will be heard in the order shown on the agenda.
