I am contacting the AGCO to submit the additional information requested for our SOP application, for the Streetsville Founders Bread and Honey Festival, 50th Anniversary.

The City of Mississauga's Clerk Office will also be sent a copy, of which they will gain approval by the City of Mississauga City Council, before they can produce a letter of non-objection. The Streetsville Founders Bread and Honey Festival is once again proud to be hosting another community event this year. We will continue our commitment to be an active part of the community and provide family fun entertainment as well as bring visitors into downtown Streetsville

We intend to utilize the licensed premises and patio of the Streetsville Royal Canadian Legion, some of the parking lot and grassy area on the north side of the building as they have used in previous years. We will have food available in the fenced off area from Maple Lodge Farms as well as Perfect Poutine. Beer will be available to be consumed in the fenced off areas. We will have live bands performing and entertainment on the stage/patio for everyone. The entire property is owned by the Streetsville Royal Canadian Legion. We are hoping to attract 500 or more people.

No additional buildings will be constructed and we will use tents for shelter of the serving areas only. The conditions and careful procedures as directed by the Mississauga Fire Department will be followed in regards to the positioning of all cooking units and fire extinguisher quantity and placement. We will be controlling event access with comprehensive fencing and volunteers acting as our identified Staff to secure all entry and exit points. A warm welcome to the advice and attendance of Peel Regional Police is always extended and appreciated and we expect many officers will take the time to visit as they have in the past.

The Streetsville Founders Bread and Honey Festival has never committed or experienced any disturbances of bylaws or liquor infractions at any of our events and we plan on keeping our record unblemished. We assure total compliance with all Municipal Fire, Health and AGCO and Security regulations. We eagerly look forward to once again serving our community.
