## Consolidated Recommendation

The City recommends that the application be refused.

## Application Details

The applicant requests the Committee to approve a minor variance to allow an existing driveway with a width of 7.63m (approx. 25.03ft) whereas By-law 0225-2007, as amended, permits a maximum driveway width of 6.0m (approx. 19.7ft) in this instance.

## Background

**Property Address:** 503 Parkview Blvd

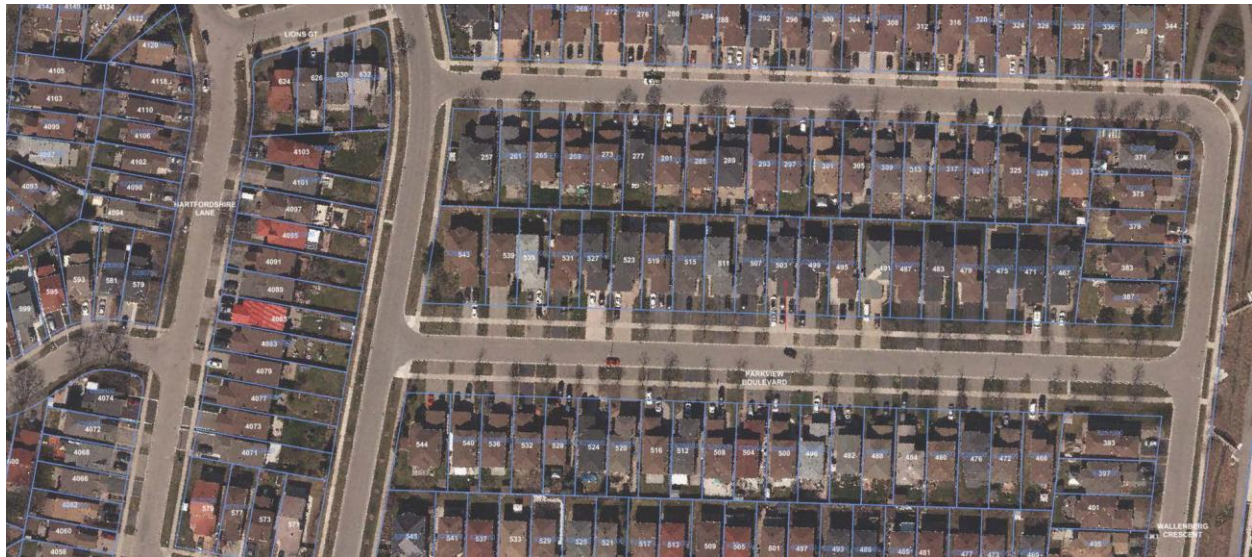

### Site and Area Context

The subject property is located north-east of the Mavis Road and Burnhamthorpe Road West intersection in the Creditview neighbourhood. It currently contains a two-storey detached dwelling with an attached garage. Limited landscaping and vegetative elements are present in the front yard. The property has an approximate lot frontage of +/- 10.3m (33.8ft), which is

characteristic of surrounding lots. The surrounding area context includes detached dwellings on similarly sized lots as well as townhouse dwellings and high density residential developments.

The applicant is proposing to maintain the existing driveway requiring a variance for driveway width.



## Comments

### Planning

Section 45 of the *Planning Act* provides the Committee of Adjustment with the authority to grant relief from the requirements of a municipal zoning by-law. Approval of applications must meet the requirements set out under 45(1) and/or 45(2) (a) or (b) in the *Planning Act*.

Staff comments concerning the application of the four tests to this minor variance request are as follows:

The subject property is located in the Creditview Neighbourhood Character Area and is designated Residential Low Density II in Schedule 10 of the Mississauga Official Plan (MOP). Section 9.1 of the MOP states that driveway widths and associated setbacks should respect the identity and character of the surrounding context.

The applicant is proposing a driveway width of 7.63m (25.03ft). The planned character of the area is that of residential dwellings serviced by appropriately sized driveways that can accommodate the parking required by the zoning by-law for each property. The intent of the driveway width by-law regulations are to permit a maximum driveway width that can accommodate two vehicles parked side by side, with the remainder of the front yard being soft landscaped area.

Staff note that the proposed driveway can easily facilitate the parking of 3 vehicles across, contrary to the intent of the zoning by-law. Furthermore it represents a significant amount of hardscaping that, in the opinion of staff, is out of character for the surrounding area. Staff note that an additional variance for soft landscaped area in the front yard may also be required, which staff are unlikely to support.

Staff are of the opinion that, as currently proposed, the driveway does not meet the general intent or purpose of the zoning by-law and is not minor in nature. Staff therefore recommend that the application be refused.

## **Appendix 2 – Zoning Comments**

In the absence of a Development application we are unable to confirm the accuracy of the information provided, or determine whether additional variance(s) may be required. It should be noted that a zoning review has NOT been completed. The applicant is advised that should they choose to proceed without zoning verification, a full zoning review may result in further variances being required in the future.

For scope of work that does not require Site Plan Approval/Building Permit/Zoning Certificate of Occupancy Permit, the applicant may consider applying for a Preliminary Zoning Review application. A detailed site plan drawing and architectural plans are required for a detailed zoning review to be completed. A minimum of 6-8 weeks is required depending on the complexity of the proposal and the quality of information submitted.
