## **Local Benchmarking**

The below information was provided through consultation with the Canadian Protocol network, a group created and leveraged by Strategic Communications and Initiatives Division.

Municipality	Process
Toronto	Takes the approach that precedence flows from the host so when the City is host, the Mayor takes precedence.
Ottawa	In 2009 the Office of Protocol reached out to the Department of Canadian Heritage regarding the Order of Precedence. Paul Leblanc, Chief of Protocol at Canadian Heritage, raised the following points when trying to establish an Order of Precedence for city events: "When deciding who should take precedence when preparing an event, I often refer to who holds the gold, makes the golden rule". This is helpful when thinking of funding announcements where the Federal and Provincial Governments are partners in the funding of a project being announced for the city. "The Mayor is King of his own backyard and therefore precedence should be given to him/her. This seems to be a change in policy for the Federal Government. It would seem that for events hosted by the city, the Mayor would take precedence and then the decisions would have to be made if the Federal Order of Precedence of the Provincial Order of Precedence should then be followed for all other representatives in attendance.

	Speaking Order
	The Mayor and Members of Council are hosts for official City events that are ceremonial in nature.
	The Mayor will speak first and convey official greetings from the City. The organizing department in consultation with the Protocol Office may determine appropriate speaking roles in consultation with the Mayor's Office. Elected officials speak before other speakers in the following order:
	Mayor or Acting Mayor or relevant Committee Chair
	<ul> <li>Local ward Councillor(s) if the event is not considered city- wide</li> </ul>
	Regional Chair
	<ul> <li>Area Member of Parliament (MP), and</li> </ul>
	Area Member of Provincial Parliament (MPP)
Calgary	The following are Calgary's general guidelines. They noted that there is 'negotiation' at times, based on who is involved, purpose of event,

Quebec	etc.  Order of precedence  The City uses the Government of Alberta's order of precedence when it comes to introductions and speaking order at special events. Typically, introductions are from most senior position to junior position and speaking order is junior position to most senior position. Note that there are always exceptions to the rule depending on who is in attendance, who is hosting the event, and the purpose of the event. If there are multiple Members of Legislative Assembly to be introduced, put them in order based on the date of first election and then in alphabetical order by last name.  For funding announcements held at the City Hall:
Quebee	Mayor > Federal Government* > Provincial Government*  (*depending on who holds the largest funding)
Winnipeg	Winnipeg follows Manitoba's order of precedence.
