Consolidated Recommendation

The City recommends that the Committee have regard for all comments and evidence provided by the applicant and area residents when assessing if the application meets the requirements of Section 45 (1) of the Planning Act.

Application Details

The applicant requests the Committee to approve a minor variance to allow the existing dwelling proposing a gross floor area of 325.11sq m (approx. 3499.46sq ft) whereas By-law 0225-2007, as amended, permits a maximum gross floor area of 321.49sq m (approx. 3460.49sq ft) in this instance.

Site and Area Context

The subject property is located on the south side of Bristol Road West, east of the McLaughlin Road intersection. It currently contains a two-storey detached dwelling with an attached garage. Limited landscaping and vegetative elements are present in both the front and rear yards. The property has a lot area of +/- 535.82m² (5,767.52ft²), which is characteristic of other detached dwellings along this portion of Bristol Road West. The surrounding context is predominantly residential, consisting of detached and townhouse dwellings. Commercial uses are present at the McLaughlin Road intersection.

The applicant is proposing interior alterations, requesting a variance for gross floor area.



Comments

Planning

Section 45 of the *Planning Act* provides the Committee of Adjustment with the authority to grant relief from the requirements of a municipal zoning by-law. Approval of applications must meet the requirements set out under 45(1) and/or 45(2) (a) or (b) in the *Planning Act*.

Staff comments concerning the application of the four tests to this minor variance request are as follows:

The subject property is located in the Hurontario Neighbourhood Character Area and is designated Residential Low Density II in Schedule 10 of the Mississauga Official Plan (MOP). This designation permits varying built forms, including detached and duplex dwellings. Section 9 of the MOP promotes development with appropriate urban form and site design, regulating that such development is compatible with: the existing site conditions, the surrounding context, and the landscape of the character area.

The applicant is proposing interior alterations that impact the calculation of gross floor area. No additional massing or additions are being constructed as part of the proposal and no notable exterior changes will occur at all. Furthermore the requested increase is exceedingly minor in nature. Staff are of the opinion that the application is appropriate to be handled through the minor variance process and that the application raises no concerns of a planning nature.
