Hi Stephanie,

Here are my comments:

While I am opposed to the sale of Cannabis products in Mississauga, I am going under the assumption that this will pass a council vote.

That being the case, I would request that the City of Mississauga enact a zoning bylaw to keep Cannabis stores out of residential neighbourhoods.

I understand the the AGCO has this clause in their legislation:

"Municipalities that have opted-in may not create a licensing system respecting the sale of cannabis nor pass a bylaw that distinguishes land or building use for cannabis from any other kinds of use. "

I would argue that enacting a zoning bylaw limiting the location of Cannabis stores to 800m from residential neighbourhoods does not violate that clause. It is not restricting land use or building (retail space can still be used to sell Cannabis). In my neighbourhood I am aware of a retail space that may be looking at leasing to a Cannabis store that is within 600m of 3 schools (closest one being one 190m), and will be located directly across the street from a private school residence.

An amendment to the existing Zoning By Law Mississauga Zoning By Law section 2.1.2.1.1 Minimum Separation Distance from Residential Zones already limits the location to 800.0m from residential neighbourhoods of these businesses:

Adult Entertainment Establishment  
Body-Rub Establishment  
Adult Video Store  
Night Club

I would ask the Council add Cannabis stores to this list.

If it can not be done, I would ask that the Council reject opting-in to the sale of Cannabis in Mississauga until such time the City has control over where retail stores can be placed.
