Consolidated Recommendation

The City recommends the application be refused.

Application Details

The applicant requests the Committee to approve a minor variance to allow a cube van to park on the driveway proposing:

- 1. A vehicle length of 7.6m (approx. 24.93ft) whereas By-law 0225-2007, as amended, permits a vehicle length of 5.6m (approx. 18.37ft) in this instance; and,
- 2. A vehicle height of 2.9m (approx. 9.51ft) whereas By-law 0225-2007, as amended, permits a vehicle height of 2.0m (approx. 6.56ft) in this instance.

Background

Property Address: 401 Winfield Terrace

Mississauga Official Plan

Site and Area Context

The subject property is located within the Hurontario Neighbourhood Character Area, south-east of the Eglinton Avenue West and Confederation Parkway intersection. It is an interior lot containing a two-storey detached dwelling with an attached garage. Limited landscaping and

vegetative elements are present in the front yard. The property has an approximate frontage of +/- 16.52m (54.19ft), characteristic of lots in the area. The surrounding context is predominantly residential, consisting of two-storey detached and semi-detached dwellings on similarly sized lots.

The applicant is proposing to park a commercial vehicle on the property requiring variances for vehicle height and length.



Comments

Planning

Section 45 of the *Planning Act* provides the Committee of Adjustment with the authority to grant relief from the requirements of a municipal zoning by-law. Approval of applications must meet the requirements set out under 45(1) and/or 45(2) (a) or (b) in the *Planning Act*.

Staff comments concerning the application of the four tests to this minor variance request are as follows:

The subject property is designated Residential Low Density II in Schedule 10 of the Mississauga Official Plan (MOP). The Residential Low Density II designation permits detached dwellings.

The applicant is requesting minor variances to allow for a commercial motor vehicle to be located on a driveway located in the front yard of the subject property. The zoning by-law permits commercial motor vehicles to be parked in residential zones subject to specific parameters outlined in section 4.1.10 of the zoning by-law.

The intent of limiting the size of commercial motor vehicles being parked in residential zones is to ensure that larger commercial motor vehicles are stored and parked in employment or commercial zones, and not on residentially zoned properties. Planning staff are of the opinion

that the variances requested are excessive and that the drawings provided do not indicate any existing or proposed screening measures to mitigate any potential massing impacts caused by the commercial motor vehicle. Staff are concerned that the variances, if approved, will cause massing impacts to the adjacent property owners and the streetscape.

While planning staff is not in a position to interpret the zoning by-law, staff note additional variances pertaining to driveway width and driveway setback to side lot line may be required. Staff note the drawings provided only depict the width of the driveway within the garage face. The drawings should include the continuous hard surfaced landscaping material added to both sides of the driveway that extend outwards beyond the garage face.

As such, staff recommend the application be refused.

Appendix 2 – Zoning Comments

In the absence of a Development application we are unable to confirm the accuracy of the information provided, or determine whether additional variance(s) may be required. It should be noted that a zoning review has NOT been completed. The applicant is advised that should they choose to proceed without zoning verification, a full zoning review may result in further variances being required in the future.

For scope of work that does not require Site Plan Approval/Building Permit/Zoning Certificate of Occupancy Permit, the applicant may consider applying for a Preliminary Zoning Review application. A detailed site plan drawing and architectural plans are required for a detailed zoning review to be completed. A minimum of 6-8 weeks is required depending on the complexity of the proposal and the quality of information submitted.
