A by-law to amend the Noise Control By-law 0360-1979, as amended, to make certain housekeeping amendments

WHEREAS sections 8, 9 and 11 of the *Municipal Act, 2001*, as amended (the "*Municipal Act, 2001*") authorize the Council of The Corporation of the City of Mississauga to pass by-laws necessary or desirable for municipal purposes;

AND WHEREAS section 129 of the *Municipal Act, 2001,* empowers a local municipality to prohibit and regulate with respect to noise and vibration;

AND WHEREAS Council of The Corporation of the City of Mississauga ("Council") enacted the Noise Control By-law 0360-1979, as amended (the "Noise Control By-law");

AND WHEREAS on June 28, 2023, Council of The Corporation of the City of Mississauga passed By-law 0131-2023, which amended the Noise Control By-law to implement a one year pilot project to allow live music along the Lakeshore corridor and Streetsville Business Improvement Area district from Thursday to Saturday until 11:00 p.m. and within the Cooksville Business Improvement Area district until 11:00 p.m. on Saturdays only;

AND WHEREAS on June 28, 2023, Council of The Corporation of the City of Mississauga passed By-law 0122-2023, which amended the Noise Control Bylaw to implement recommendations relating to the City's Noise Control Program Review and to repeal the Nuisance Type Noise By-law 0785-1980, as amended, as set out in the corporate report from the Commissioner of Corporate Services, dated May 23, 2023 and entitled "Noise Control Program Review Update;

AND WHEREAS Council of The Corporation of the City of Mississauga wishes to make certain housekeeping amendments to the Noise Control By-law to reference section 3.1 (persistent sound) and section 4.1 (live music pilot project) in the applicable sections of the Noise Control By-law.

NOW THEREFORE, the Council of The Corporation of the City of Mississauga **ENACTS** as follows:

- 1. That the Noise Control By-law 0360-1979, as amended, be further amended, as follows:
 - (a) by deleting "Section 3 and 4" in section 5 and replacing it with "Section 3, 3.1 and 4";
 - (b) by deleting "Section 3 and 4" in subsection 7(1) and replacing it with "Section 3, 3.1, 4 and 4.1"; and
 - (c) by adding "and any references to Section 4.1" after "Section 4.1" in subsection 8(3).
