

A by-law to amend By-law No. 555-2000,  
as amended, being the Traffic By-law

**WHEREAS** pursuant to section 11(3)1 of the *Municipal Act, 2001*, S.O. 2001, c. 25 as amended, a Council may enact by-laws respecting highways, including parking and traffic on highways;

**AND WHEREAS** Council of The Corporation of the City of Mississauga desires to make certain amendments to By-law 555-2000, as amended, being the Traffic By-law;

**NOW THEREFORE**, the Council of The Corporation of the City of Mississauga ENACTS as follows:

1. That Schedule 1 of By-law 555-2000, as amended, be amended by DELETING the following:

<u>SCHEDULE 1</u> <u>FIVE HOUR PARKING LIMIT EXEMPTION</u>				
COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES EXEMPTED	COLUMN 5 MAXIMUM TIME LIMIT
Folkway Drive	South	A point 110 metres east of Glen Erin Drive and a point 50 metres easterly thereof	Anytime	15 hours

2. That Schedule 10 of By-law 555-2000, as amended, be amended by DELETING the following:

Montevideo Road	North	Corfu Road and a point 100 metres easterly thereof	Anytime

6. That Schedule 11 of By-law 555-2000, as amended, be amended by ADDING the following:

West Avenue & Gardner Avenue	Northbound on West Avenue Eastbound on Gardner Avenue Southbound on West Avenue Westbound on Gardner Avenue

7. That Schedule 31 of By-law 555-2000, as amended, be amended by ADDING the following:

<u>SCHEDULE 31</u> <u>DRIVEWAY BOULEVARD PARKING-CURB TO SIDEWALK</u>			
COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES PERMITTED
Dover Crescent	North, West and South (where a sidewalk exists)	Entire roadway	Anytime
Fergo Avenue	Both	Entire roadway	Anytime
Haines Road	East	Rymal Road and Riley Court	Anytime

8. This By-law shall not become effective until the portions of the highway(s) affected are properly signed.
