11.2 Conflict in the Middle East (A.Q. Mufti, Citizen Member)

A.Q. Mufti spoke to the conflict in the Middle East, Anti-Semitism and Islamophobia the importance of a cease fire and open access to humanitarian aid.

Councillor Reid spoke to actions that can be taken by the Committee at the Municipal level and keeping it focused on the residents and their lived experience. Mr. Mufti spoke to a successful event organized by the Interfaith Council of Halton, a peace prayer that took place at the Town Hall in Halton Region. Councillor Reid inquired if it is possible to

organize an interfaith prayer meeting. Sacha Smith, Manager Secretariat, Access & Privacy responded to Councillor Reid's inquiry.

Tony Oseivhi commented about the Committee hearing the concerns that were expressed by Kathy Leff and looking into what actions can be done to address some of the concerns locally.

Mr. Oseivhi, Mr. Mufti and Councillor Reid noted that they would like to be involved with the Inter-faith Working Group. Councillor Damerla suggested that members could advise the Legislative Coordinator at a later date on their interest in participating on the Working Group.
