The afternoon studies no cycle delay was experienced. Based on the above information, the Traffic Systems and ITS Business Unit does not recommend the installation of an eastbound left-turn arrow at the intersection of Erin Centre Drive at Tenth Line at this time. Staff will continue to monitor this location as traffic conditions and volumes continue to evolve.</p> <p>c. Based on before and after studies when the devices were installed in 2019, the operating speeds were reduced by 8 km/h and speed limit compliance was increased by over 30%.</p> <p>d. Road Safety staff do not recommend ASE on roadways where physical traffic calming devices have already been installed. Speed cushions have been installed on Erin Centre Boulevard for a number of years and have had a positive impact on reducing speeding and aggressive driving. A multi-year study across the City shows that the average speed of roadways, where traffic calming has been installed, have been reduced by an average of 11.5km/h and compliance of the posted speed limit has increased by 37%.</p> <p>e.
