

A by-law to amend City By-laws 0169-2016, 0047-2017, 0088-2017 and 0012-2020, as amended, being by-laws delegating authority to enter into various fire protection and rescue service agreements with other municipalities

WHEREAS pursuant to the provisions of the *Fire Protection and Prevention Act*, 1997 S.O. 1997, c.4, as amended, a municipality may enter into an agreement to: (a) provide such fire protection services as may be specified in the agreement to lands or premises that are situated outside the territorial limit of the municipality; and (b) receive such fire protection services as may be specified in the agreement from a fire department situated outside the territorial limits of the municipality;

AND WHEREAS on July 6, 2016, By-law 0169-2016, being a by-law to authorize the execution of the Fire Protection Services Agreement between The Corporation of the City of Mississauga and The Corporation of the Town of Halton Hills was passed by Council of The Corporation of the City of Mississauga;

AND WHEREAS on March 29, 2017, By-law 0047-2017, being a by-law to authorize the execution of a Trench Rescue Services Agreement between The Corporation of the City of Mississauga and The Corporation of the City of Burlington was passed by Council of The Corporation of the City of Mississauga;

AND WHEREAS on June 7, 2017, By-law 0088-2017, being a by-law to authorize the execution of a Fire Protection Services Agreement between The Corporation of the City of Mississauga and The Corporation of the Town of Milton was passed by Council of The Corporation of the City of Mississauga;

AND WHEREAS on January 22, 2020, By-law 0012-2020, being a by-law delegating authority to the City Manager and Chief Administrative Officer and the City Clerk to enter into fire protection and rescue service agreements with municipalities was passed by Council of The Corporation of the City of Mississauga;

AND WHEREAS The Corporation of the City of Mississauga wishes to be able to amend and extend its fire protection and rescue services agreements with various municipalities;

AND WHEREAS an amendment to Section 1 to By-laws 0169-2016, 0047-2017, 0088-2017 and 0012-2020, as amended, is required to allow for the delegated authority to enter into any necessary documents ancillary to the respective fire protection and rescue services, including any subsequent amending and extension agreements;

NOW THEREFORE the Council of The Corporation of the City of Mississauga hereby ENACTS as follows:

1. That Section 1 of By-law 0169-2016, be deleted and replaced with the following:
 - “1. That the City Manager and Chief Administrative Officer and the City Clerk, or their designates, be authorized to enter into a Fire Protection Services Agreement with The Corporation of the Town of Halton Hills on behalf of the Corporation of the City of Mississauga, and all necessary documents

ancillary thereto including any subsequent amending and extension agreements, in a form satisfactory to the City Solicitor.”

2. That Section 1 of By-law 0047-2017, be deleted and replaced with the following:

“1. That the City Manager and Chief Administrative Officer and the City Clerk, or their designates, be authorized to enter into a Trench Rescue Services Agreement with The Corporation of the City of Burlington on behalf of The Corporation of the City of Mississauga for the purpose of Mississauga providing trench rescue services to Burlington, and all necessary documents ancillary thereto including any subsequent amending and extension agreements, in a form satisfactory to the City Solicitor.”


3. That Section 1 of By-law 0088-2017, be deleted and replaced with the following:

“1. That the City Manager and Chief Administrative Officer and the City Clerk, or their designates, be authorized to enter into a Fire Protection Services Agreement with The Corporation of the Town of Milton on behalf of The Corporation of the City of Mississauga, and all necessary documents ancillary thereto including any subsequent amending and extension agreements, in a form satisfactory to the City Solicitor.”

4. That Section 1 of By-law 0012-2020, be deleted and replaced with the following:

“1. That the City Manager and Chief Administrative Officer and the City Clerk, or their designates, are delegated the authority to enter into fire protection and rescue service agreements with municipalities for a term of five (5) years, and all necessary documents ancillary thereto including any subsequent amending and extension agreements, in a form approved by the City Solicitor.”
