However, to provide sufficient time for pedestrians to safely cross the major street, in this case, Tomken Road, pedestrians are required to press the push button. In addition, the pedestrian crossing times are calculated based on industry guidelines to ensure that pedestrians have enough time to cross the intersection safely.</p>
