- 5.1 <u>Distracted Driving and Pedestrian Safety Campaign Updates, Karen Flores, Supervisor,</u> <u>Communications, Amy Camara, Communications Coordinator and Catherine Nguyen-</u> <u>Pham, Communications Coordinator</u>

Karen Flores, Supervisor, Departmental Communications spoke to the delay in the launch of the Distracted Driving campaign due to the Covid-19 Pandemic and introduced Catherine Nguyen-Pham and Amy Camara, Communications Coordinators.

Ms. Nguyen-Pham provided a presentation and spoke to the success of the September Distracted Driving campaign launch; tactics; goals and statistics. Ms. Camara spoke to the October launch of the Pedestrian Safety campaign; provided statistics; background and plans. Ms. Camara spoke to plans and programs to increase pedestrian safety; improvements to infrastructure, budget for the campaign and media tactics.

In response to Sunil Sharma, Citizen Member, Ms. Flores spoke to sharing the campaign social media and tags to other municipalities and agencies such as the Ministry of Transportation and the Region of Peel in an effort to expand the scope of viewers outside of Mississauga.

6. <u>DEPUTATIONS - Nil</u>

6.1 Glenn Voakes, resident to speak with respect to cycling fatalities

Mr. Voakes spoke to cycling fatalities in Mississauga, addressed concerns about roadway safety and made enquiries with respect to the role of the Mississauga Cycling Advisory Committee, Road Safety Committee, Traffic Safety Advisory Committee and Active Transportation staff.

In response to Mr. Voakes, Councillor Saito, Chair spoke to the mandate of the Road Safety Committee and others; the role of the Police, staff and Councillors as it relates to location specific concerns.

In response to Councillor Saito, S/Sgt Allan Villers, Peel Region Police will provide a response via email with respect to the duration of accident investigations related to cycling fatalities and collisions.

Colin Patterson, Supervisor, Road Safety spoke to the City's process, noting there can be more than one road authority involved, depending on the location of an incident which is necessary to understand in order to make changes and informed decisions. Councillor Saito provided examples of instances where the City had acted immediately to implement new safety measures in an effort to prevent future incidents and noted this is only possible when the cause of the incident is known.

Jonathan Giggs, Resident spoke to the Committee at 11:15 AM, following "Matters to be Considered".

Mr. Giggs made enquiries with respect to the cumulative kilometres of residential and arterial roads in relation to item 8.2.; the necessity of sign installation and speed limit defaults on Mississauga roadways. In response, Colin Patterson, Supervisor, Road Safety spoke to providing a summary of length for the requested road classifications; the regulations and requirements for establishing speed limits and legalities for speed limit sign display.

Natalie Halff, Resident made enquiries regarding item 8.6; Covid-19 recovery plan opportunities with Active Transportation; infrastructure improvements and noted the importance of ensuring cycling and pedestrian safety.

In response, to Ms. Halff, Councillor Saito, Chair, provided background information on the original request for the dedicated bike lanes in Ward 9 and spoke to the rationale for the location and duration of the lanes.

8. <u>MATTERS TO BE CONSIDERED</u>

8.1 <u>Ministry of Transportation - Hockey Gear Safety Campaign, Melissa Brabant, Regional</u> <u>Marketing Planner</u>

Melissa Brabant, Regional Marketing Planner, Ministry of Transportation spoke to the Hockey Equipment advertisements, provided background information and noted they are posted on every Hockey Association web page to raise awareness about safety. Councillor Saito, Chair, spoke to the opportunity to have the advertisements placed inside all City arenas.

8.2 <u>Update on the Speed Limit Sign Installation, Colin Patterson, Supervisor, Road Safety</u> (Verbal)

Items 8.2-8.4 were heard together.

Mr. Patterson spoke to the background of the installation of the new Speed Limits signs and provided an update with respect to budget approval; timing; impacts of Covid-19 on implementation; recruitment of staff and noted there are approximately 9000 signs that need removal, revision and installation. Mr. Patterson spoke to the implementation of school safety zones, the By-law requirements and approval process.

Mr. Patterson provided an update on the Automated Speed Enforcement program and spoke to enforcement; system design and mobility; impact of Covid-19 and existing pressures on the court system and noted a further update will come forward in the near future as staff continue to investigate.

Mr. Patterson provided an update on the Quiet Streets Project and spoke to background information; barricade installations to limit aggressive driving; location and concerns addressed by surrounding neighbourhoods.

Councillor Ras spoke the experience in Ward 2 and impacts on traffic. In response, Mr. Patterson spoke to the intent of the program and efforts to move traffic away from neighbourhoods, to use alternate routes rather than feeder streets. Mr. Patterson spoke to the design of barricades, being 2 metres in width and noted a review of the process will be conducted going forward.

In response to Suzanne Doyle, Mississauga Cycling Advisory Representative, Mr. Patterson spoke to the considerations for interactions at pinch points between cyclists and motorists, noting there have been no reports of such occurrences. Mr. Patterson advised that considerations will be made with respect to location, width of barricades and roadways as well as stability of barricades if the program moves forward.

In response to Sunil Sharma, Citizen Member, Mr. Patterson spoke the communication process in advance of installations and advised feedback can be provided to the business units through 3-1-1 as staff have been provided with the information necessary to respond to enquiries. Mr. Patterson noted direct communication to residents depends on the scale of impact and whether it is directly to resident property. Mr. Patterson discussed the significance of education and awareness, noting it will be a large part of the process going forward.

Councillor Saito, Chair, spoke to the opportunity to include the Quiet Streets project as Committee Campaign item for 2021 as part of the work plan. Tony Power, Citizen Member and Vice Chair, spoke to considerations for renaming the project to more clearly identify the scope and intent.

Ms. Hunter spoke to the Pedestrian Master plan; project background; vision; timelines and how the Road Safety Committee can contribute by completing the survey provided. Ms. Hunter noted the plan will review sidewalks and crossings of multi-use trails at roadways; conduct surveys and host a virtual workshop. Ms. Hunter requested the Committee communicate any concerns to her directly.

Councillor Saito, Chair, spoke to the relationship between the plan and the Committee's focus as it relates to intersection safety, visibility of pedestrians at crossings and location of stop bars.

Suzanne Doyle, Mississauga Cycling Advisory Representative (MCAC) spoke to a recommendation stemming from MCAC with respect to a request for information on cycling collision statistics and common locations, including incidents involving pedestrians. Ms. Doyle spoke to sharing the information once received. In response to Ms. Doyle, Ms. Hunter confirmed all network connections will be considered in the plan. Colin Patterson, Supervisor, Road Safety spoke to the benefits of reviewing general trends of incidents rather than location specific.

Councillor Saito, Chair, spoke to the success of the temporary dedicated bike lanes in Ward 9; feedback, and noted a full-some evaluations would need to be done. Thomas Barakat, Ontario Good Roads Association spoke to the location.
