

A by-law to amend Administrative Penalty  
By-law 0282-2013, as amended, to provide  
for increased administrative parking  
penalties

WHEREAS sections 8, 9 and 11 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, ("*Municipal Act, 2001*") authorize The Corporation of the City of Mississauga to pass by-laws necessary or desirable for municipal purposes;

AND WHEREAS subsection 102.1(1) of the *Municipal Act, 2001* provides that a municipality may require a person to pay an administrative penalty if the municipality is satisfied that the person failed to comply with any by-laws respecting the parking, standing or stopping of vehicles;

AND WHEREAS the Province adopted the "Administrative Penalties" regulation, O. Reg. 333/07 pursuant to the *Municipal Act, 2001* which applies to administrative penalties in respect of the parking, standing or stopping of vehicles;

AND WHEREAS the Council of The Corporation of the City of Mississauga enacted Administrative Penalty By-law 0282-2013 (the "Administrative Penalty By-law") on December 11, 2013;

AND WHEREAS on February 12, 2025, the Council for The Corporation of the City for Mississauga passed Resolution 0030-2025 approving revised General Committee Recommendation GC-0044-2025 to enact a by-law to amend Schedules "A", "A-1", "B" and "D" of the Administrative Penalty By-law, as amended, to increase administrative penalty amounts for parking offences;

NOW THEREFORE the Council of The Corporation of the City of Mississauga, ENACTS as follows:

1. That Schedule "A" (City of Mississauga Administrative Penalty By-law Designated By-law Provisions Traffic By-law 0555-2000) of Administrative Penalty By-law 0282-2013, as amended, is hereby deleted and replaced with Schedule "A" attached.
2. That Schedule "A-1" (City of Mississauga Administrative Penalty By-law Designated By-law Provisions Traffic By-law 0555-2000 Lakefront Increased Penalty Zone) of Administrative Penalty By-law 0282-2013, as amended, be further amended as follows:
  - (a) That Item 5 be revised by deleting reference to \$100.00 under Column 3 (Administrative Penalty) and replacing it with \$120.00, as follows:

3. That Schedule “B” (City of Mississauga Administrative Penalty By-law Designated By-law Provisions Fire Route By-law 0216-2023) of Administrative Penalty By-law 0282-2013, as amended, be further amended as follows:

- (a) That Item 1 be revised by deleting reference to \$175.00 under Column 3 (Administrative Penalty) and replacing it with \$225.00, as follows:

- (a) That Item 1 be revised by deleting reference to \$400.00 under Column 3 (Administrative Penalty) and replacing it with \$450.00, as follows:



5. That this by-law shall come into force on April 1, 2025.

**SCHEDULE "A"**  
**CITY OF MISSISSAUGA ADMINISTRATIVE PENALTY BY-LAW**  
**DESIGNATED BY-LAW PROVISIONS**  
**TRAFFIC BY-LAW 0555-2000**

1. For the purposes of section 3 of this By-law, Column 1 in the following table lists the provisions in Traffic By-law 0555-2000, as amended that are hereby designated for the purposes of 3(1)(b) of the Regulation.
2. Column 2 in the following table sets out the short form wording to be used in a Penalty Notice for the contravention of the designated provisions listed in Column 1.
3. Column 3 in the following table sets out the Administrative Penalty amounts that are payable for contraventions of the designated provisions listed in Column 1.
