

A by law to amend By-law 0184-2022, being
the Reserves and Reserve Funds By-law,
as amended, to add, delete and rename
various Reserves and Reserve Funds

WHEREAS sections 8, 9 and 11 of the *Municipal Act, 2001* authorize a municipality to pass by-laws necessary or desirable for municipal purposes, and in particular paragraph 3 of subsection 11(2) authorizes by-laws respecting the financial management of the municipality;

AND WHEREAS By-law 0184-2022 establishes and maintains The Corporation of the City of Mississauga’s reserves and reserve funds (the “By-law”);

AND WHEREAS Schedule "A" to the By-law identifies Reserves and Schedule "B" to the By-law identifies Discretionary Reserve Funds;

AND WHEREAS the Council of The Corporation of the City of Mississauga passed Resolution _____ on April 16, 2025 to approve the addition, deletion and renaming of various Reserves and Discretionary Reserve Funds as set out in this by-law;

NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

- 1. That Schedule "A" of By-law 0184-2022 is hereby amended by deleting the following Reserve:

- 2. That Schedule "B" of By-law 0184-2022 is hereby amended by adding the following Discretionary Reserve Funds:

35534	Churchill Meadows Tennis Facility Reserve Fund	Provides funds for the capital repair and refurbishment of the Tennis Facility within the Mattamy Sports Park at Churchill Meadows Community Center.	Other Reserve Funds
35601	Building Services Reserve Fund	To be used to stabilize revenues related to building services.	Other Reserve Funds

3. That Schedule “B” of By-law 0184-2022, as amended, is hereby further amended by deleting the contents of Column II and Column III in the row which identifies Reserve Fund 35588 in Column I and replacing it with the following:

COLUMN II

Churchill Meadows Pool
Reserve Fund

COLUMN III

To capture the yearly operating budget
contribution to the Churchill Meadows Pool
Reserve Fund.
