## 10.2 Clarification on difference between Notice of Motions VS Council Direction

Councillor A. Tedjo requested clarification at the November 27, 2024, Council meeting.

Members of the Committee engaged in a discussion and spoke to the following:

- The need for clarity between staff direction and Council direction.
- The establishment of a threshold for providing direction, particularly in timeconsuming matters.
- Updating the Council Procedure By-law to clarify the distinction between motions and direction.
- Educating citizens and Council on proper procedures and documentation.

Diana Rusnov, Director, Legislative Services and City Clerk, responded to questions and clarified that direction is less formal than motions, with motions requiring staff work and being recorded. Geoff Wright, City Manager, noted that Members of Council should be consulting staff before drafting motions.

- The potential for Members of Council to hold Chair positions instead of Citizen Members for Advisory Committees.
- Challenges in managing public interactions and controversial matters.
- Support for Citizen Members as Chairs in certain committees, such as Accessibility Advisory Committee due to lived experience.
- Concerns about Citizen Members' preparedness for contentious meetings.
- The need to review and update the Terms of Reference for Advisory Committees.
- The importance of training for Citizen Members in Chair or Vice-Chair roles.
- The suggestion to assess which Advisory Committees are suitable for Citizen Members and provide appropriate training.
