In response to the action items that were referred to the Transportation and Works Department for review, City staff provides the following comments:

A comprehensive review was completed on Ogden Avenue to determine if the subject roadway requires additional signage.

The review revealed several sign deficiencies in the vicinity of the three schools on Ogden Avenue.

A limited amount of sign deficiencies require utility locates (stakeouts) in order to

accommodate the request; which will delay signage installation. The signage that can be installed on existing posts will be arranged to be completed more rapidly.
