

A by-law to authorize the execution of
performance agreements under Corporate
Policy and Procedure 05-03-05 - Procuring
Performers for City-Produced Public Events
and to repeal By-law 0073-2013, as amended

WHEREAS the Council for The Corporation of the City of Mississauga (the “City”) wishes to enact a new by-law to replace By-law 0073-2013, as amended, being a by-law to authorize the execution of performance agreements under Corporate Policy and Procedure 05-03-05 - Procuring Performers for City-Produced Culture Events, to update position titles and signing authority contract value limits for staff in line with recent administrative restructuring at the City as well as with the City’s Procurement By-law 0013-2022, as amended;

AND WHEREAS on June 11, 2025, the Council for the City passed Resolution _____ approving General Committee Recommendation _____ to revise Corporate Policy and Procedure 05-03-05 - Procuring Performers for City-Produced Public Events (the “Policy”), to enact a new by-law to authorize the execution of performance agreements, and to repeal By-law 0073-2013, as amended;

AND WHEREAS the Policy requires the execution of a performance agreement, in a form satisfactory to Legal Services, by the City and each performer it engages to perform at City-produced public events, and sets out the signing authorities associated with the value of each agreement;


NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

- 1. That the following persons are hereby authorized to execute performance agreements including all necessary amendments, extensions, renewals or other documents ancillary thereto, on behalf of The Corporation of the City of Mississauga, in a form satisfactory to Legal Services, pursuant to Corporate Policy and Procedure 05-03-05 - Procuring Performers for City-Produced Public Events:

| Title | Contract Value |

| Commissioner of Community Services (Signing authority can be delegated, in writing) | Above \$500,000 |
| Director of Recreation and Culture (Signing authority can be delegated, in writing) | Above \$125,000 up to and including \$500,000 |
| Manager of Culture and Events (Signing authority cannot be delegated. In the absence of the Manager of Culture and Events, the Director of Recreation and Culture has authority) | Above \$50,000 up to and including \$125,000 |
| Manager of Event Development (Signing authority cannot be delegated. In the absence of the Manager of Event Development, the Manager of Culture and Events has authority) | Above \$25,000 up to and including \$50,000 |
| A Supervisor with Cost Centre Authority (Signing authority cannot be delegated. In the absence of the Supervisor, the Manager with Cost Centre Authority has authority) | \$25,000 or less |

2. That By-law 0073-2013, as amended, is hereby repealed.
