Policy Statement

Special style street lights may be permitted in the City of Mississauga if the additional capital costs of providing them, over the cost of the normal City of Mississauga standard, is borne by the requesting party.

Standard

All new street lighting will consist of light emitting diode (LED) fixtures on concrete poles or attached to hydro poles and be designed in accordance with engineering standards established by the Transportation and Works Department and Alectra Power Services Inc. (formerly Enersource Power Services Inc.). Special style poles and fixtures will only be permitted if they conform to the Decorative Springdale or Modified Standard as detailed in the above standards and if the additional capital cost is borne by the requesting party.

Maintenance

The design of special style street lights must conform to either the Decorative Springdale Standard or the Modified Standard so that the maintenance costs to the City will be similar to those for the City of Mississauga standard units.
