As discussed on site, a work order has been issued to add an additional "No Stopping" sign between the existing "No Stopping" sign and the intersection of Burnhamthorpe Road West at Ridgeway Drive. The existing "No Stopping" signs' placement on the northeast side of Burnhamthorpe Road West and Ridgeway Drive are adequate.</p> <p>b. Traffic Signals has confirmed that Burnhamthorpe Road West and Ridgeway Drive will have an advanced walk phase (LPI) installed in 2025.</p> <p>c. School zone signage on Burnhamthorpe Road West is not recommended because it is not a designated school zone. It is also classified as an arterial road.</p>
