

Benchmarking: Eligibility Requirements, Minimum Contributions, Rebate Calculation Formulas and Maximum Rebate Payouts in other Municipalities

Below are details related to rebate programs in Ontario organized by eligibility requirements.

Eligibility Requirement - Limited to Residents of the Municipality:

Municipality	Residential Eligibility Requirements	Minimum Contribution	Rebate Formula	Maximum Allowable Rebate
Ajax	Eligible electors residing in Ajax	\$20	75% of eligible contributions up to the maximum.	\$187.50
Oakville	Eligible electors residing in Oakville.	\$100	50% of all eligible contributions up to the maximum.	\$600
Vaughan	Eligible electors residing in Vaughan.	\$50	75% of all eligible contributions to the maximum.	\$150
Whitby	Eligible electors residing in Whitby.	\$25	<p>If the total contribution(s) is \$100.00 or less, the rebate paid is 75% of that total.</p> <p>If the total contribution(s) is \$100.01 or more, the rebate paid is 75% of \$100.00 plus 25% of the difference between the total</p>	\$200

Eligibility Requirement - Limited to Eligible Elections and Permanent Residents of the Municipality:

Municipality	Residential Eligibility Requirements	Minimum Contribution	Rebate Formula	Maximum Allowable Rebate
Markham	Eligible electors and permanent residents of Canada residing in Markham.	\$50	75% of eligible contributions up to the maximum.	\$150

Eligibility Requirement - Limited to Residents of Ontario:

Municipality	Residential Eligibility Requirements	Minimum Contribution	Rebate Formula	Maximum Allowable Rebate
Mississauga	Eligible electors in residing in Ontario.	\$100	See page 3 of Appendix 1.	\$1,500
Ottawa	Eligible electors in residing in Ontario.	\$25.01	If the contribution by an individual to a candidate is equal to or greater than \$25.01 and not more than \$100, the rebate is 50% of the total contribution.	\$75*

Appendix 2

			If the contribution by an individual to a candidate is greater than \$100, the rebate is \$50 plus 25% of the amount by which the contribution exceeds \$100.	
Toronto	Eligible electors in residing in Ontario.	\$25.01	<p>75% of total contributions between \$25 and \$300.</p> <p>50% + \$225 of total contributions over \$300 but not more than \$1,000.</p> <p>33.33% + \$575 of total contributions more than \$1,000 to a maximum of \$1,000.</p>	\$1,000

**The maximum rebate to an individual may not exceed \$75 except for candidates who withdrew their nomination in accordance with the MEA. In such circumstances, the rebate to an individual is 75% up to a maximum of \$900.*
