## A by-law to amend User Fees and Charges By-law 0221-2024, as amended, to impose new electric vehicle charging fees

WHEREAS sections 8, 9 and 11 of the *Municipal Act, 2001*, S.O. 2001, c. 25 ("*Municipal Act, 2001*"), authorize a municipality to pass by-laws necessary or desirable for municipal purposes, and in particular paragraph 3 of subsection 11(2) authorizes by-laws respecting the financial management of the municipality;

AND WHEREAS subsection 391(1) of the *Municipal Act, 2001* provides that sections 9 and 11 of that Act authorize a municipality to impose fees or charges on any class of persons for services or activities provided or done by or on behalf of the municipality and for the use of the municipality's property, including property under its control;

AND WHEREAS the Council of The Corporation of the City of Mississauga ("Council") enacted the City of Mississauga's User Fees and Charges By-law 0221-2024, as amended, on November 27, 2024;

AND WHEREAS on June 25, 2025, Council passed Resolution \_\_\_\_\_\_\_\_\_ to amend User Fees and Charges By-law 0221-2024, as amended, to amend Schedule "D" (Parks, Forestry and Environment Fees and Charges) to incorporate electric vehicle charging fees;

NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

- 1. That User Fees and Charges By-law 0221-2024, as amended, is hereby further amended as follows:
  - (a) by adding the following new rows to the table for Parks, Marinas, Forestry & Environment on page 94 in Schedule "D" (Parks, Forestry and Environment Fees and Charges):

(b) by adding the following 'Environment Fee Notes' below the 'Forestry Fees Notes' on page 95 in Schedule "D" (Parks, Forestry and Environment Fees and Charges):

## **Environment Fee Notes:**

 Idle Fee: to be applied once charging is complete but vehicle remains in place. A 30 minute grace period applies once charging is completed. This idle fee will not be charged between 10:00PM and 8:00AM at locations where overnight parking is allowed. ENACTED and PASSED this  $25^{th}$  day of June, 2025.
