To: MAYOR AND MEMBERS OF COUNCIL

The Mississauga School Traffic Safety Action Committee presents its fifth report for 2025 and recommends:

MSTSAC-0041-2025

1. That the warrants have not been met for the placement of a school crossing guard at the intersection of Meadows Boulevard and Molly Avenue.
2. That Transportation and Works be requested to paint ladder markings on all 3 legs of the intersection at Meadows Boulevard and Molly Avenue.
3. That the principal of St. Charles Garnier Catholic Elementary School be requested to remind students to stay on east side of Meadows Boulevard at Molly Avenue to cross Meadows Boulevard with the existing crossing guard on Meadows Boulevard behind St. Charles Garnier Catholic Elementary School.
