Re: 900 Lakeshore Rd. W. building application

Please find attached a petition signed by 474 residents opposing the proposed construction of a condominium at 900 Lakeshore Rd. W. Apart from signatures by residents of Ward 2, you will note that there are 200 signatures from people attending Richard's Memorial Park. They were shocked by the scope of this project and its impact both on the surrounding green space and on availability of parking for those who rely on visits to the Park to reconnect with friends and family, as well as to benefit from the healing provided by nature for the inevitable stresses of urban living.

We have also included the online petition which gathered 1600 signatures.

As you have heard at the Planning Committee meeting, there are many areas in which this project falls short of what we have been led to expect in terms of future development in this great city and what was promised to us, as taxpayers, in the City of Mississauga Official Plan.

We therefore hope that, like your constituents, you will oppose this project and preserve the integrity of the green space which is so valuable to the city and to its residents, particularly in a time of climate change.
