

A by-law to amend By-law No. 555-2000,
as amended, being the Traffic By-law

WHEREAS pursuant to section 11(3)1 of the *Municipal Act, 2001*, S.O. 2001, c. 25 as amended, a Council may enact by-laws respecting highways, including parking and traffic on highways;

AND WHEREAS Council of The Corporation of the City of Mississauga desires to make certain amendments to By-law 555-2000, as amended, being the Traffic By-law;

NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

1. That Schedule 18 of By-law 555-2000, as amended, be amended by DELETING the following:

Halliday Avenue	A point 30 metres east of Strathy Avenue and Alexandra Avenue	30 km/h
Lisgar Drive	Yarrow Avenue and Berryman Trail	30 km/h
Mazo Crescent	Entire Roadway	30 km/h
Meredith Avenue	Delco Avenue and Atwater Avenue	30 km/h
Stonehouse Crescent	Entire Roadway	30 km/h
Tedwyn Drive	Pear Tree Road and Felina Court	30 km/h
Vista Boulevard	A point 40 metres east of Vista Drive (westerly intersection) and Erin Mills Parkway	30 km/h
Whitehorn Avenue	Pickwick Drive and 15 metres north of Weir Chase	30 km/h

2. That Schedule 18 of By-law 555-2000, as amended, be amended by ADDING the following:

Lisgar Drive	Yarrow Avenue and Berryman Trail	30 km/h Monday – Friday 6:00 am – 6:00 pm
Mazo Crescent	Entire Roadway	30 km/h Monday – Friday 6:00 am – 6:00 pm
Meredith Avenue	Delco Avenue and Atwater Avenue	30 km/h Monday – Friday 6:00 am – 6:00 pm
Stonehouse Crescent	Entire Roadway	30 km/h Monday – Friday 6:00 am – 6:00 pm
Tedwyn Drive	Pear Tree Road and Felina Court	30 km/h Monday – Friday 6:00 am – 6:00 pm
Vista Boulevard	Erin Mills Parkway and a point 40 metres east of Vista Drive (westerly intersection)	30 km/h Monday – Friday 6:00 am – 6:00 pm
Whitehorn Avenue	Pickwick Drive and 15 metres north of Weir Chase	30 km/h Monday – Friday 6:00 am – 6:00 pm


3. That Schedule 31 of By-law 555-2000, as amended, be amended by ADDING the following:

SCHEDULE 31
DRIVEWAY BOULEVARD PARKING-CURB TO SIDEWALK

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES PERMITTED
Brass Winds Place	North and West (where sidewalk exists)	Entire roadway	Anytime
Oxbow Crescent	North and East (where sidewalk exists)	Entire roadway	Anytime
Plowmans Heath	East and South (where sidewalk exists)	Entire roadway	Anytime
Targa Road	Both	Entire roadway	Anytime

4. This By-law shall not become effective until the portions of the highway(s) affected are properly signed.
